In pursuance to Secretary, Service Selection Board, Jammu letter No. SSB/Sel/Secy/2018/7998-8004 dated 11.07.2018 and Commissioner/Secretary to Government, ARI & Training Department, Civil Secretariat, J&K, Srinagar letter No. ARI/RGPs/12/2018 dated 05.09.2018, Sh. Susheel Kumar S/o Hem Lal R/o Jijote Doda is hereby appointed temporarily against the post of Junior Assistant in the Pay Level -4 (25500-81100) under RBA Category, in Ranbir Government Press, Jammu.

The appointee shall report to this office within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates in original:-

1. Academic/Technical Qualification certificate (s)
2. Matriculations/D.O.B Certificate.
3. Permanent Resident Certificate issued by the competent authority.
4. Health Certificate from the concerned CMO of the District.
5. Certificate from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self employment scheme has been taken by the appointee.
6. Relevant Category Certificate.


The appointment of the candidate shall further be made subject to the following conditions that :-

- i) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from the Additional Inspector General of Police (CID), J&K to whom a reference shall be made by the General Manager, Ranbir Government Press, Jammu, he shall have no right to claim his appointment as Junior Assistant in Govt. Press, Jammu and his appointment as such shall be deemed to have been cancelled ab-initio :
- ii) Verification/genuineness of the qualification certificates/reserved category certificates from the concerned issuing authorities.

- iii) The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory report in respect of (i) and (ii) above are received in his favour:
- iv) If, on verification, the certificates produced by the appointee proved to be fake or forged, his appointment stand as cancelled ab-initio and criminal proceeding shall be initiated against him.
- v) The appointment of the above candidate shall be governed by the SRO 202 of 2015 dated 30th June, 2015 ; and
- vi) The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before the Competent Court of Law.
