to them, for carrying out the terrorist activities in the area ; and

2. Whereas, based on the above, a Case FIR No. 72/2018 under
Sections 13 (2), 18, 19, 38 and 39 of ULA (P) Act, was registered
in the Police Station, Qaimoh, and the investigation, of the case was
set into motion. Subsequently, during the investigation, the offence under
Section 38 of ULA (P) Act was dropped and Section 20 of ULA (P)
Act was added in the case ; and

3. Whereas, during the course of investigation, the seizure memos
were prepared and the statements of witnesses acquainted with the
facts and circumstances of the case were recorded .under the relevant
provisions of law ; and

4. Whereas, during the investigation, the accused viz. Mateen
Ahmad Lone, Aijaz Ahmad Lone @ Ajaz Cable, Abid Ahmad Lone,
Sajad Ahmad Dar and Shahid Ahmad Ahanger @ Shahid Khar, were
arrested in the case and were found working for the terrorists in order
to promote terrorist activities in the area ; and

5. Whereas, during the investigation, it was established that the
accused viz. Mateen Ahmad Lone, Aijaz Ahmad Lone @ Ajaz Cable,
Abid Ahmad Lone, Sajad Ahmad Dar and Shahid Ahmad Ahanger @
Shahid Khar, were working as Over Ground Workers (OGWs) for the
terrorists of HM, a banned outfit, particularly the terrorists viz. Owais
Ahmad Lone @ Raja, Javid Ahmad Bhat and Farooq Ahmad Bhat @
Nali, and under a well knit criminal conspiracy were providing logistic
support to them, besides, were voluntarily harbouring the said terrorists
for carrying out the terrorist activities in the area ; and

6. Whereas, the accused terrorists viz. Owais Ahmad Lone @ Raja and Javid Ahmad Bhat, have been killed in the different encounters with the Security Forces and the proceedings under the law would abate against them ; and

Whereas, on the basis of the investigation, the statements of witnesses recorded and other evidence collected, the Investigating Officer, has established a *prima facie* involvement of the below mentioned accused for the commission of offences punishable under Sections of the Unlawful Activities (Prevention) Act, 1967, as shown against their names :ô
