Whereas, on 08.09.2023, a reliable information was received by the Police Station, Pulwama, to the effect that two persons identified as Sahil Firdous Sheikh R/o Puchal, Pulwama and Shahid Gull R/o Wagum, Pulwama, have been working as OGWs for a terrorist namely Aqib Shergojri, and are providing logistic support to him, besides, facilitating the terrorist for transportation of his arms/ammunition from

Whereas, on the basis of the investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has established a *prima facie* involvement of the below mentioned accused for the commission of offences punishable under Sections of the Unlawful Activities (Prevention) Act, 1967, as shown against their names :ô

8. Whereas, the accused terrorist viz. Aqib Shergojri, is absconding and proceedings under section 299 Cr.PC have been proposed to be initiated against him ; and

9. Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary file and all the other relevant documents relating to the case and has come to the conclusion that *prima facie* case is made out against the above accused ; and

10. Whereas, after perusing the Case Diary file, the relevant documents and also taking into consideration the views of the Authority appointed under sub-section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above mentioned accused for their prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 45 the Unlawful Activities (Prevention) Act, 1967, the
