Whereas, on 20-09-2023, the Police Station, Anti Narcotics Task Force, (ANTF) Kashmir, received a reliable information that one drug peddler identified as Zaheed Ahmad Khoja S/o Mohammad Amreek Khoja R/o Mandian Keran, Kupwara, is carrying contraband Heroin like narcotic substance and is going to Gangbugh, Srinagar, in order to sell the same among the other drug peddlers ; and

8. Whereas, during the investigation, it was established that the
 accused viz. Zaheed Ahmad Khoja, was working for the terrorists of
 LeT /HM banned outfits particularly the Pakistani based terrorist viz.
 Zameer Ahmad Lone, and under a well knit criminal conspiracy was
 raising funds for the terrorists for carrying out the terrorist/unlawful
 activities in the area ; and

9. Whereas, during investigation, some other persons identified as
 Zaheer Ahmad Lone S/o Bashir Ahmad Lone R/o Mindian, Keran,
 Kupwara,Iqra Akhtar D/o Gh. Mohammad Wani R/o Darzipora,
 Kupwara, Abdul Lateef Joo S/o Mohammad Maqsood Joo R/o Mandian,
 Keran, Mumtaz Ahmad Lone, and unidentified male/female drug
 peddlers/other associates were found involved in the case and investigation
 with respect to them shall continue to bring out their role/involvement
 in the case and the Supplementary Charge Sheet against them would
 be filed in the Court of Competent jurisdiction ; and

10. Whereas, on the basis of the investigation, the statements of
 witnesses recorded and other evidence collected, the Investigating
 Officer, has established a *prima facie* involvement of the below
 mentioned accused for the commission of offences punishable under
 Sections of the Unlawful Activities (Prevention) Act, 1967, as shown
