Notification

Jammu, the 22nd March, 2024.

SO-203.& Whereas, on 30-09-2023, a reliable information was received by the Police Station, Pulwama, to the effect that two persons identified as Ishtiyaq Nazir Dar S/o Nazir Ahmad Dar and Abass Majeed Parray S/o

Abdul Majeed Parray residents of Ashmander, Pulwama, are working for the terrorists of LeT, a banned outfit, and are facilitating them for the transportation of their arms / ammunition from one place to another, besides, on the directions of the terrorists were distributing the terror fund among the terrorists and OGWø for carrying out terrorist activities in the area; and

2. Whereas, based on the above, a Case FIR No. 260/2023 under Section 18, 20, 39 and 40 of ULA (P) Act, was registered in the Police Station, Pulwama, and the investigation, of the case was set into motion. Subsequently, during the investigation, the offence under Section 38 of ULA (P) Act was added in the case; and

3. Whereas, during the investigation, the seizure memos were prepared and the Statements of witnesses acquainted with the facts and circumstance of the case were recorded under the relevant provisions of law; and

4. Whereas, during the investigation, it was found that the accused viz. Ishtiyaq Nazir Dar and Abass Majeed Parray, were in contact with two terrorists of LeT, a banned outfit namely Owais Feroz Mir S/o Feroz Ahmad Mir R/o Frestabal, Pampore A/P Pakistan and Abrar-ul-Islam S/o Not known R/o Pakistan, through virtual mode and were working for them in order to promote terrorist activities in the area ; and

5. Whereas, during the investigation, it was found that the accused viz. Ishtiyaq Nazir Dar, received some arms / ammunition / cash and hand grenades from an unknown person at Pattan and later on handed over arms / ammunition / cash to one active terrorist of Let banned outfit namely Ehsan-ul-Haq Sheikh S/o Abdul Rasheed Sheikh R/o Murran Pulwama, on the directions of terrorists viz. Abrar-ul-Islam and Owais Feroz Mir, besides on their directions received a huge amount from some unknown persons and distributed the same among the terrorists, their families and sympathizers of terrorists. Subsequently, during the investigation, an amount of Rs. 3,08000/- were seized in the case; and

6. Whereas, during the investigation, it was established that the accused viz. Ishtiyaq Nazir Dar and Abass Majeed Parray, were working as Over Ground Workers (OGWs) for the terrorists of LeT, banned outfit particularly the terrorists viz. Owais Feroz Mir, Abrar-ul-Islam and Ehsan-ul-Haq Sheikh, and under a well knit criminal conspiracy providing logistic support to them, besides, were raising fund for the terrorist for carrying out terrorists activities in the area; and

7. Whereas, the investigation, in respect of unknown person shall continue to ascertain their actual identify and to bring out their role / involvement in the case and the supplementary charge sheet against them would be filed in the Court of competent jurisdiction; and

8. Whereas, on the basis of investigation, the statements of witnesses recorded and other evidence collected, the Investigating Officer, has established a *prima facie*, involvement of below mentioned accused for the commission of the offences punishable under sections of the Unlawful Activities (Prevention) Act, 1967, as shown against their names :ô

Abass Majeed Parray, has been found juvenile and in view of Section 1(4) of the Juvenile justice (Care and Protection of Children) Act, 2015 the apprehension, detention, prosecution, penalty or imprisonment shall be governed by the said Act; and
