the Naka Party tried to escape but was chased down on the spot and
identified as Hayder Showkat Wani S/o Showkat Ahmad Wani R/o
Chinar Lane, Gulbarg Colony, Buchpora, Srinagar. During search, the
Police recovered 01 Pistol with magazine and 18 rounds from a bag
carried by the accused; and

2. Whereas, based on the above, a case FIR No.259/2023under
Sections121, 121-A, 122 IPC, 7/25 Arms Act, and Sections 18, 20 , 23
and 38 of ULA (P) Act, was registered in the Police Station, Sopore, and
the investigations, of the case was set into motion ; and

3. Whereas, during the investigation, the site plan of the place of
occurrence and the seizure memos were prepared and the statements of
witnesses acquainted with the facts and circumstances of the case were
recorded under the relevant provisions of law ;and

4. Whereas, during the investigation, it was found that the accused
viz. Hayder Showkat Wani, was in contact with a terrorist of LeT, a
banned outfit,namely,Bilal Hamza Mir S/o Mohammad Hamza Mir R/o
Brath Kalan, Sopore, who provided the recovered arms/ammunition to
the accused viz. HayderShowkat Wani, in order to promote terrorist
activities in the area ; and

5. Whereas, during the investigation, it was found that on 11-10-
2023, the accused viz. Hayder Showkat Wani, went missing from his
home and joined the terrorist ranks of LeT, a banned outfit ; and

6. Whereas, during the investigation, it was established that the
accused viz. Hayder Showkat Wani, was associated with the terrorist
organization of LeT, a banned outfit and under a well knit criminal
conspiracy procured arms/ammunition from the terrorist viz. Bilal
Hamza Mir, for carrying out the terrorist activities in the area and to
wage war against the Government of India; and

7. Whereas, the investigation, in respect of accused terrorist viz. Bilal Hamza Mir, shall continue to bring out his role/involvement in the case and the Supplementary Charge sheet against him would be filed in the court or competent jurisdiction ; and

8. Whereas, on the basis of investigation, the statement of witnesses recorded and the other evidence collected, the Investigating Officer has established *prima facie* involvement of below mentioned accused for the commission of the offences punishable under sections as shown against hisname:ô

Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused ;and

10. Whereas, after perusing the Case Diary File,the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities(Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for his prosecution under the provisions of law ; and

11. Whereas, the Government has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that *prima facie* case is made out against the above accused under the aforementioned provision of the Indian Penal Code (IPC) : and
