redicalizing/ provoking youth to join the terrorist ranks, thereby poses a threat to sovereignty and integrity of India; and

2. Whereas, based on the above,a case FIR No. 120/2023 U/S 13,18, 18-B 38 and 39 of ULA (P) Act, was registered in the Police Station, Vilgam, and the investigation of the case was set into motion, Subsequently, during the investigation, the offences under Section 201 IPC was added in the case; and

3. Whereas, during the investigation,the accused viz. Ishrat Ahmad Mir @ Ishfaq, was arrested in the case and it was found that the accused was in contact with a paskistan based terrorist of LeT/ TRF banned outfit namely Tallat Ibn Azaad @ Talha, through virtual mode and was working for him in order to promote terrorist activities in the area; and

4. Whereas, during the course of investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law, and

5. Whereas,during the investigation, two more person identified as Shahid Ahmad Mir @ Shahid Bhai S/o Sabzar Ahmad Mir R/o Sangaspora,Kulgam and Amjid Ali Gojar @ Hamza Bhai S/o Mohammad Razak Gojar R/o Inayatpur,Rajouri,were found involved in the commission of crime. Subsequently, the accused were also arrested in the case; and

6. Whereas during the investigation, it was established that the accused viz. Ishrat Ahmad Mir @ Ishfaq, Shahid Ahmad Mir @ Shahid Bhai and Amjid Ali Gojar @ Hamza Bhai were working as Over Ground Workers (OGWs) for the terrorists particularly the Pakistan based terrorists viz. Tallat Ibn Azaad @ Talha, and under a well knit criminal conspiracy were providing logistic support to him, besides the accused viz. Ishrat Ahmad Mir @ Ishfaz and Shahid Ahmad Mir @ Shahid Bhai were motivating the youth to join the terrorist ranks for carrying out the terrorist activites in the area; and

7. Whereas, the investigation, in respect of Pakistan based handler viz. Tallat Ibn Azzad @ Talha, shall continue to ascertain his actual identity and to bring out his role/ involvement in the case and the

Supplementary Charge Sheet against him would be filed in the Court of competent jurisdiction; and

8. Whereas, on the basis of the investigation, the statements of witnesses recorded and other evidence collected, the Investigating Officer, has established *prima facie* involvement of the below mentioned accused for the commission of offences punishable under Sections of the Unlawful Activities (Prevention) Act, 1967, as shown against their names :-

9. Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused; and

10. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above mentioned accused for their prosecution under the provisions of law.

Now therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Ishrat Ahmad Mir @ Ishfaq, Shahid Ahmad Mir @ Shahid Bhai and Amjid Ali Gojar @ Hamza Bhai, for the
