SO-316. Whereas, on 12-12-2023, the Police Station, Bandipora, received a docket to the effect that a reliable information was received about the movement of some unknown terrorists in the area.



with the Pakistani handlers viz. Abu Bakar and Shahbaz Lone, in order to promote terrorist activities in the area. The accused lady viz. Sadaf Jan, was also in contact with the Pakistani handler viz. Abu Bakar, and was working for him ; and

7. Whereas, during the investigation, it was found that the accused viz. Musaib Khursheed Dar and Shafqat Nabi Mir, received 03 Hand Grenade and 05 Pistols from one @ Mushtaq Ahmad S/o Unknown R/o Kashmir, on the directions of Pakistani handlers viz. Abu Bakar, and Shahbaz Lone and Handed over the same to the accused viz. Adil Tariq Wasil, who concealed the Hand Grenades and Pistols in a tin shed of his maternal uncle. Subsequently, during the investigation, 02 Hand Grenades, 03 Pistols, 08 Magazines and 115 Rounds were recovered at the instance of accused viz. Adil Tariq Wasil ; and

8. Whereas, during the investigation, it was found that on 11-12-2023, the accused Pakistani handlers viz. Abu Bakar and Shahbaz Lone, directed the accused viz. Adil Tariq Wasil, Musaib Khursheed Dar and Shafqat Nabi Mir, to kill any non-local/Police personnel in the area and on the date of occurrence as per the directions the accused viz. Adil Tariq Wasil and Shafqat Nabi Mir , went to Bandipora, in order to carry out attack upon the Police/Security Forces and on their way were arrested by the Naka Party at Patushai, Bandipora, along with the arms/ammunition ; and

9. Whereas, during the investigation, it was established that the accused viz. Adil Tariq Wasil, Musaib Khursheed Dar, Shafqat Nabi Mir and Sadaf Jan, were working as Over Ground Workers (OGWs) for the terrorists of JeM, a banned outfit, particularly the terrorists viz. Nasir Ahmad Darzi, Mohsin Mushtaq Bhat, Abu Bakar and Shahbaz Lone, respectively and under a well knit criminal conspiracy were providing logistic support to them, besides, the accused viz. Adil Tariq Wasil and Shafqat Nabi Mir, procured the arms/ammunition and Hand Grenades from the Pakistani handlers viz. Abu Bakar and Shahbaz Lone, through

other relevant documents relating to the case and has come to the conclusion that *prima facie* is made out against the above accused ; and

14. Whereas, after perusing the Case Diary File,the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities(Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for their prosecution under the provisions of law.

Now, therefore,in exercise of the powers conferred bySub-Section (2) of Section 45 of the Unlawful Activities (Prevention)Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Adil Tariq Wasil, Shafqat Nabi Mir, Musaib Khursheed Dar and Mst. Sadaf Jan, for the commission of offences punishable under the relevant Sections of ULA (P) Act, as indicated against the each accused at Para (12) above, arising out of FIR No. 152/2023 of Police Station, Bandipora.
