Srinagar, the 8th June, 2024.

SO6327. Whereas, on 21-12-2023, a reliable information was received by the Police Station, Tral to the effect that some youth of the area are in constant touch with terrorist handlers of proscribed terrorist organization based in Pakistan through different communications and are facilitating the transportation and delivery of arms/ammunition to terrorists for promoting terrorist activities, besides, have received

illegal arms/ammunition with the directions to carry out attack upon
the Police/Security Force in the area. It was further learnt that some
persons are also in contact with terrorist associates lodged in different
jails and are managing coordinating and facilitating supply of arms/
ammunition and terror money to facilitate target killings and recruitment
of youth into terrorist cadres ; and

2. Whereas, based on the above, a Case FIR No. 139/2023 under
Section 7/25 Arms Act and 13, 18, 18-B, 23, 38, 39 and 40 of ULA(P)
Act, was registered in the Police Station, Tral, and the investigation, of
the case was set into motion. Subsequently, during the investigation,
the offences under Sections 18-B and 40 of ULA (P) Act were
dropped and Section 5 ESA and 20 of ULA (P) Act was added in the
case ; and

3. Whereas, during the investigation, nine persons identified as
Mst. Rukaya Farooq D/o Farooq Ahmad Dar R/o Gamraz, Tral, Irshad
Ahmad Khan S/o Gh. Nabi Khan, Mohammad Yaseen Malik S/o
Mohammad Ashraf Malik residents of Panzoo, Tral, Sarwar Ahmad Mir
S/o Gh. Mohi-Ud-Din Mir R/o Bathin, Khrew, Zuhaib Nabi S/o Gh. Nabi
Bhat R/o Larrow, Jageer, Adil Farooq S/o Farooq Ahmad R/o Khrew,
Umer Chopan S/o Ab. Hamid Chopan R/o Laroow Jageer, Illiyas
Ahmad Reshi S/o Ab. Majeed Reshi R/o Charsoo, Awantipora and
Imtiyaz Ahmad Lone S/o Mohammad Akram Lone R/o Gamraz, Tral,
were found involved in the case ; and

4. Whereas, during the investigation, the accused viz. Mst.
Rukaya Farooq, Irshad Ahmad Khan, Mohammad Yaseen Malik,
Sarwar Ahmad Mir, Zuhaib Nabi, Illiyas Ahmad Reshi and Imtiyaz
Ahmad Lone, were arrested in the case and 03 Pistols, 5 magazines,
50 rounds, 02 hand grenades, 20 Pika rounds, 01 JeM banner and some
explosive material were recovered at the instances of accused viz. Mst.
Rukaya Farooq, Irshad Ahmad Khan, Mohammad Yaseen Malik,
Sarwar Ahmad Mir, Illiyas Ahmad Reshi and Zuhaib Nabi respectively.
The accused viz. Adil Farooq, was already arrested by Police Srinagar
in Case FIR No. 84/2021 of Police Station Shaheed Gunj, and the other
accused viz. Umer Chopan, was detained under the provisions of J&k
Public Safety, Act, 1978 : and

8. Whereas, during the investigation, the accused viz. Mohammad Yaseen Malik, has been found juvenile and in view of Section 1(4) of the Juvenile Justice (Care and Protection of Children) Act, 2015, the apprehension detention, prosecution, penalty or imprisonment shall be governed by the said Act ; and

9. Whereas, the accused terrorists viz. Owais Feroze and Shaheen Baie, are absconding and proceedings under Section 299 Cr. P.C. have been proposed to be initiated against them ; and

10. Whereas, the authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967 has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused ; and
