Srinagar, the 12th June, 2024.

SO6332. Whereas, on 29-09-2021, during the search of two missing persons namely, Danish Khursheed Bhat S/o Khursheed Ahmad Bhat R/o Ladi, Imamsahib and Kamran Bashir Hajam S/o Bashir Ahmad Hajam R/o Babapora, Zainapora, the Police Station, Zainapora, reliably came to know that the missing persons had joined the terrorist ranks of LeT, a banned outfit, for carrying out the terrorist activities in the area ; and

2. Whereas, based on the above a case FIR No. 116/2021 under Sections 18, 20, and 38 of ULA(P) Act, was registered in the Police Station, Zainapora, and the investigation, of the case was set into motion. Subsequently, during the investigation, the offence under Section 18 of ULA(P) Act, was dropped from the case ; and

3. Whereas, during the investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, it was found that on 01-10-2021, the accused viz. Kamran Bashir Hajam, was arrested by Shopian Police, alongwith arms/ammunition for which a separate case FIR No. 117/2021 was registered in Police Station Zainapora. Subsequently, his custody was changed in the instant case ; and

5. Whereas, during the investigation, it was established that on 12-08-2021 and 18-09-2021, the accused viz. Danish Khursheed Bhat and Kamran Bashir Hajam, left from their residential houses respectively and joined the terrorist ranks of LeT, a banned outfit, for carrying out the terrorist activities in the area ; and

6. Whereas, the accused terrorist viz. Danish Khursheed Bhat, has been killed in an encounter with the Security Forces and the proceedings under the law would abate against him ; and

7. Whereas, on the basis of the investigation, the statements of witnesses recorded and other evidence collected, the Investigating Officer, has established a *prima facie* involvement of the below mentioned accused for the commission of offences punishable under Sections of the Unlawful Activities (Prevention) Act, 1967, as shown against his names :ô

8. Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused ; and

9. Whereas, after perusing the Case Diary File the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for his prosecution under the provisions of Law.

Now, therefore, in exercise of powers conferred by Sub-Section (2) of Section 45 of Unlawful Activities (Prevention) Act 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Khamran Bashir Hajam, for the commission of offences punishable under Sections 20 and 38 of ULA(P) Act, arising out of FIR No. 116/2021 of Police Station, Zainapora.
