case ; and

3. Whereas, during the course of investigation, the site plan of the  
place of occurrence and the seizure memos were prepared and the  
statements of witnesses acquainted with the facts and circumstances  
of the case were recorded under the relevant provisions of law; and

4. Whereas, during the investigation, five terrorists of HM,a  
banned outfit,identified as javid Ahmad Matoo @ Saqib S/o Abdul  
Ahad Matoo R/o Khushal Matoo, Sopore, Mohammad Rafi Najar @  
Rouf Najar S/o Mohd. Abdullah Najar R/o Mumkak Batpora  
Sopore,Imtiyaz Ahmad Kandoo @ Fayaz S/o Khaliq Kandoo R/o Kralteng,  
Sopore A/P Pakistan, Tariq Ahmad Mir @ Tariq Mavar S/o Ghulam  
Mohammad Mir R/o Qalamabad Handwara and Abdul Qayoom  
Najar @ Jan Sahib S/o Mohammad Abdullah Najar R/o Batpora,  
Sopore, were found involved in the commission of crime; and

5. Whereas, during the investigation, it was found that the accused  
viz. Javid Ahmad Matoo @ Saqib and Mohammad Rafi Najar @ Rouf  
Najar, were already arrested by the Special Cell, Delhi and National  
Investigation Agency (NIA) in case FIR No. 07/2024 and Case RC No.  
29/2021/NIA/NDLS respectively.Subsequently, their custody was changed  
in the instant case. During the investigation, 01 Pistol, 02 magazines, 10  
rounds and some incriminatory material were recovered at their instance  
respectively; and

6. Whereas, during the investigation, two more persons identified as  
Ahmadullah Malla S/o Abdul Ahad Malla R/o Dalal Mohalla, Srinagar and  
Bilal Ahmad Kaloo S/o Abdul Rehman Kaloo R/o Takiyabal, Sopore were  
found involved in the case. Subsequently, the accused viz. Ahmadullah  
Malla, was arrested in the case and the accused viz. Bilal Ahmad Kaloo,  
was found already arrested by Handwara Police in Case FIR No. 68/  
2021 of Police Station Dangi wacha and is presently lodged in District  
Jail, Baramulla ; and

7. Whereas, during the investigation, it was found that the accused  
viz. Ahmadullah Malla was in contact with the terrorists viz. Mohammad  
Rafi Najar @ Rouf Najar, and Javid Ahmad Matoo @ Saqib, and was  
providing shelter to the said terrorists in his residential house, besides,  
the accused viz. Ahmadullah Malla, facilitated the accused terrorist viz.

12. Whereas, the accused terrorist viz. Imtiyaz Ahmad Kandoo @ Fayaz, is absconding, and proceedings under section 299 Cr. PC have been proposed to be initiated against him; and

13. Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that *prima facie* case is made out against the above aqccused; and

14. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for their prosecution under the provision of law; and

15. Whereas, the Government has independently examined the Case Diary File and all the other velevant documents relating to the case and has come to the conclusion that *prima facie* case is made out against the above accused under the aforementioned provision of the Ranbir Penal Code (RPC).

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act 1967, and Section 196 of the Code of Criminal Procedure 1973, the
