SO-378. Whereas, on 28-12-2023, an information was received by the Police Station, Sopore, to the effect that three persons identified as Abdul Majeed Sofi @ Majid Bisati S/o Ali Mohammad Sofi R/o Bilal

Colon, New Colony, Sopore, Javaid Ahmad Teeli S/o Nissar Ahmad
Teeli R/o Armapora, Sopore and Javaid Ahmad Reshi S/o Mohd Jamal
Reshi R/o Harwan, Sopore, had left to Gulf Countries on valid travel
documents and thereafter, went to Pakistan in order to join the terrorist
ranks to promote terrorism in the UT of J&K; and

2. Whereas, based on the above, a case FIR No.307/2023 under
Sections 13, 18-B, 20 and 39 of ULA(P) Act, was registered in the Police
Station Sopore, and the investigation of the case was set into motion.
Subsequently, during the investigation, the offences under Section 7/25
Arms Act 4/5 ESA and Sections 18, 19, 23 and 38 of ULA (P) Act of
ULA (P) Act were added in the case ; and

3. Whereas, during the course of investigation, the seizure memos
were prepared and the statements of witnesses acquainted with the facts
and circumstances of the case were recorded under the relevant
provisions of law; and

4. Whereas, during the investigation, three more persons identified as
Abdul Rashid Najar S/o Abdul Ahad Najar R/o Naseembagh, Sopore,
Abdul Jameel Lara S/o Abdul Gani Lara R/o Nigeenbagh, Sopore A/P
Green Town, Sopore and Mohammad Rafi Najar S/o Abdullah Najar R/o
Mumkak, Batpora, Sopore, were found involved in the commission of
offence. Subsequently, the accused were arrested and during the
investigation, 02 Pistols, 02 Magazines, 27 Rounds, 282 AK Rounds,
92 SLR Rounds, 02 IEDS and some incriminatory material were
recovered at the instance of accused viz. Abdul Rashid Najar and Abdul
Jameel Lara, respectively; and

5. Whereas, during the investigation, it was found that the accused
viz. Abdul Rashid Najar, Abdul Jameel Lara and Mohammad Rafi
Najar, were in contact with the terrorists of HM/LeT banned outfits viz.
Abdul Majeed Sofi @ Majid Bisati, Javaid Ahmad Teeli, Javaid Ahmad
Reshi, Abdul Qayoom Najar S/o Abdul Ahad Najar R/o Batapora,
Sopore, Javaid Ahmad Matoo S/o Abdul Gani Matoo R/o Khushal
Matoo, Sopore and Shamusdin Khooru S/o Ghulam Ahmad Khooru R/o
Krankshivan, Sopore, and were working for them in order to promote

 terrorist activities in the area. The accused viz. Mohammad Rafi Najar and Javaid Ahmad Matoo,were found already arrested by Sopore Police in Case FIR No. 42/2013 of Police StationTarzoo. Subsequently, their custody was changed in the instant case ; and

6. Whereas, the investigation, in respect of accused viz. Javaid Ahmad Teeli, Javaid Ahmad Reshi and ShamusdinKhooru, shall continue to bring out their role/involvement in the case and the Supplementary Charge Sheet again them would be filed in the court of competent jurisdiction ; and

7. Whereas,during the investigation,it was established that the accused viz. Abdul Rashid Najar, Abdul Jameel Lara and Mohammad Rafi Najar, were working as Over Ground Workers (OGWs) for the terrorists viz. Abdul Majeed Sofi @ Majid Bisati, Abdul Qayoom Najar and Javaid Ahmad Matoo, and under a well knit criminal conspiracy were providing shelter/logistic support to them, besides the accused viz. Abdul Rashid Najar and Abdul Jameel Lara, procured arms/ammunition from the terrorists for carrying out the terrorists activities in the area ; and

8. Whereas, the accused terrorist viz. Abdul Qayoom Najar, has been killed in an encounter with the Security Forces and the proceedings under the law would abate against him ; and

9. Whereas, on the basis of investigation, the statements of witnesses recorded and the other evidence collected, the Investigating Officer has established *prima facie* involvement of below mentioned accused for the commission of the offences punishable under Sections of the Unlawful Activities (Prevention) Act, 1967,as shown against theirnames:ô
