### Jammu and Kashmir Government—Notifications.

Srinagar, the 25th October, 2024.

SO-521.—Whereas, on 08-04-2024, an information through reliable means was received at Police Station, Heerpora, to the effect that some unknown terrorists have fired indiscriminately upon Foreign Tourists staying in Hotel Danish Resorts at Borihalan, Heerpora, with their illegal

arms/ammunition, with the intention to kill them, resulting in injuries to their driver and guide namely Dil Ranjay Singh S/o Param Hans Singh R/o Rudrapur, Utranchal, who were shifted to hospital for treatment. The unknown terrorists after the commission of crime escaped from the spot ; and

2. Whereas, based on the above, a Case FIR No. 11/2024 Under Sections 307 IPC, 7/27 Arms Act and Sections 16,18, 20 & 38 of ULA (P) Act, came to be registered in the Police Station, Heerpora, and the investigation, of the case was set into motion. Subsequently, during the investigation, the offence under Section 7/25 Arms Act and Section 23 and 39 of ULA(P) Act, were added in the case; and

3. Whereas, during the investigation, the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, the role of 02 persons namely Abid Ahmad Parrey S/o Bashir Ahmad Parrey R/o Chotipora and Kashif Ahmad Thoker S/o Khurshid Ahmad Thoker R/o Baba Mohalla, Shopian, came to the fore in the commission of crime. Subsequently, the accused were arrested and were found in contact with 03 terrorists namely; Abid Ramzan Sheikh S/o Mohammad Ramzan Sheikh, Shahid Ahmad Kuttay S/o Mohammad Yousuf Kuttay residents Chotipora, Shopian and Amir Bashir Dar S/o Bashir Ahmad Dar R/o Darmadoora, Shopian;; and

5. Whereas, during the investigation, it was found that on the date of occurrence the accused viz. Shahid Ahmad Kuttay and Amir Bashir Dar, with the assistance of accused Abid Ahmad Parrey, fired upon the Foreign Tourists at Borihalan, Heerpora, on the directions of accused terrorist viz. Abid Ramzan Sheikh, and escaped from the spot. During the investigation, 06 AK-47 rounds were recovered at the instance of accused viz. Abid Ahmad Parrey ; and

6. Whereas, the investigation conducted by the investigating agency has *prima facie* established that the accused viz. Abid Ahmad Parrey and Kashif Ahmad Thoker were working as Over Ground Workers (OGWs) for the terrorists of LeT, a banned outfit, namely, Abid Ramzan Sheikh, Shahid Ahmad Kuttay, and Amir Bashir Dar, and under a well knit criminal conspiracy were providing logistic and other support to them in order to promote terrorist activities in the area ; and

7. Whereas on the basis of the investigation, the statements of witnesses recorded and the other evidence collected, the Investigating Officer, has established *prima facie* involvement of the below mentioned accused for the commission of offences punishable Under Sections of the Unlawful Activities (Prevention) Act, 1967, as shown against their names :—

8. Whereas, the accused viz. Abid Ramzan Sheikh, Shahid Ahmad Kuttay and Amir Bashir Dar, are absconding and proceedings Under section 299 Cr. PC are proposed to be initiated against them ; and

9. Whereas, the Authority, appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Dairy File and all the

other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused ; and

10. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for his prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Abid Ahmad Parrey, Kashif Ahmad Thoker, Abid Ramzan Sheikh, Shahid Kuttay and Amir Bashir Dar, for the commission of offences punishable under the relevant Sections of ULA (P) Act, as indicated against the each accused at Para (7) above, arising out of FIR No. 11/2024 of Police Station, Heerapora.
