## PART I—B

### **Jammu and Kashmir Government—Notifications.**

GOVERNMENT OF JAMMU AND KASHMIR  
CIVIL SECRETARIAT—HOME DEPARTMENT, J&K.

Notification

Srinagar, the 5th November, 2024.

SO-530.—Whereas, on 07.05.2022, a reliable information was received by the Police Station, Soura, to the effect that some unknown terrorists fired upon a Police Official at Aiwa Bridge, Soura, Srinagar, with their illegal arms/ ammunition, with the intention to kill him,

resulting in serious injury to him. The injured Police official was shifted to hospital for treatment and the unknown terrorists after the commission of crime escaped from the spot ; and

2. Whereas, based on the above, a Case FIR No. 39/2022 Under Sections 307 IPC, 7/27 Arms Act and Sections 13, 18 and 20 of ULA (P) Act, was registered in the Police Station, Soura, and the investigation, of the case was set into motion. Later on, the injured Police Official identified as Ghulam Hassan Dar S/o Ghulam Rasool Dar R/o Danmer, Sangam, Srinagar, succumbed to his injuries. Subsequently, during the investigation, the offence under Section 307 IPC was dropped and the offences under Section 302 IPC and Sections 16, 38, 39 of ULA (P) Act were added in the case ; and

3. Whereas, during the course of investigation, the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, two terrorists of LeT/TRF, banned outfit, identified as Adil Ahmad Parray @ Hafiz Adil S/o Habibullah Paray R/o Badergund, Ganderbal and Basit Ahmad Dar @ Kamran S/o Late Abdul Rashid Dar R/o Redwani, Qaimoh, Kulgam, were found involved in the commission of crime ; and

5. Whereas, during the investigation, it was established that the accused viz. Adil Ahmad Parray @ Hafiz Adil and Basit Ahmad Dar @ Kamran, were members of LeT, a banned outfit, and on the date of occurrence under a well knit criminal conspiracy fired upon the Police official namely, Ghulam Hassan Dar, at Aiwa bridge, Soura, Srinagar, which resulted death of the deceased person ; and

6. Whereas, the sanction against the accused viz. Basit Ahmad Dar @ Kamran, has been accorded by the Government vide Notification S.O. No. 07 dated 03.01.2024, and the accused viz. Adil Ahmad Parray @ Hafiz Adil, got killed in an encounter with the Security Forces and the

proceedings under the law stands abated against him, besides, the investigation, of the case was continued ; and

7. Whereas, during the further investigation, the role of one more person identified as Faisal Ahmad Lone S/o Abdul Rehman Lone R/o Kokerbagh, Zoonimar, Soura, came to fore in the commission of crime. Subsequently, the accused was arrested and was found in close contact with accused viz. Basit Ahmad Dar @ Kamran, who provided a photograph of deceased Police official to accused viz. Faisal Ahmad Lone, for keeping an eye on him and getting his routine timing for going to duty and coming back from duty, prior to his killing which was recovered at his instance ; and

8. Whereas, the investigation conducted by the investigating agency has *prima facie* established that the accused viz. Faisal Ahmad Lone, was working as Over Ground Worker (OGW) for the terrorists viz. Basit Ahmad Dar @ Kamran and Adil Ahmad Parray @ Hafiz Adil, and in furtherance of conspiracy was providing logistic support to them, besides, facilitated the said terrorists to kill the deceased constable ; and

9. Whereas on the basis of the investigation, the statements of witnesses recorded and the other evidence collected, the Investigating Officer, has established *prima facie* involvement of the below mentioned accused for the commission of offences punishable in terms of the provisions of Unlawful Activities (Prevention) Act, 1967, as shown against his name :—

10. Whereas, the Authority, appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Dairy File and all the other relevant documents relating to the case and has come to the

conclusion that a *prima facie* case is made out against the above accused ; and

11. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for his prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Faisal Ahmad Lone, for the commission of offences punishable under Sections 13, 16, 18 and 39 of ULA (P) Act, arising out of FIR No. 39/2022 of Police Station, Soura.
