Notification

Jammu, the 6th December, 2024.

SO-560.—Whereas, on 13-06-2024, a written docket was received at the Police Station, Karnah, to the effect that a Naka was established by the Police at Khawarpora, Nallah. During the checking, 02 suspects

were noticed in suspicious circumstances, who, while seeing the Naka party tried to escape from the spot but were tactfully apprehended and identified as Shafeeq Ahmad Sheikh S/o Late Mohammad Shafi Sheikh R/o Khawarpora, Karnah and Mohammad Tariq Malik S/o Gh. Ahmad Malik R/o Bagh Bella, Karnah. During their personal search about 450 grams of narcotics like substance were recovered from their possession respectively ; and

2. Whereas, based on the above, a Case FIR No. 33/2024 under Section 8/21 NDPS Act, was registered in the Police Station, Karnah, and the investigation of the case was set into motion. Subsequently, during the investigation, the offences under Section 29 NDPS Act, 7/ 25 Arms Act. and Sections 13, 18, 20, 23, 38 and 39 of ULA(P) Act were added in the case ; and

3. Whereas, the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, role of another person namely Parvaiz Ahmad Turkhan S/o Mohammad Maqbool Turkhan R/o Sudpora Forward, Karnah, came to fore in the commission of crime, who was subsequently arrested in the case and during investigation, 03 Pistols, 06 rnazazines, 76 rounds along with some explosive material were recovered at his instance ; and

5. Whereas, the investigation conducted by the investigating agency has *prima facie* established that the accused viz. Shafeeq Ahmad Sheikh, Mohammad Tariq Malik and Parvaiz Ahmad Turkhan were working as Over Ground Workers (OGWs) for the terrorist namely Ab. Hameed Sheikh S/o Fakir Sheikh R/o Hajitara, Karnah, who in furtherance of criminal conspiracy provided the recovered arms/ ammunition and narcotic substances to them for promotion of terrorism in the area ; and

6. Whereas, on the basis of the investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has established *prima facie* involvement of the below mentioned

accused for the commission of offences punishable in terms of the provisions of the Unlawful Activities (Prevention) Act, 1967, as shown against their names :—

7. Whereas, the accused Ab. Hameed Sheikh is absconding and proceeding 299 Cr.PC. have been proposed to be initiated against him ; and

8. Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary file and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused ; and

9. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above mentioned accused for their prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act,

1967, the Government hereby accord sanction for launching prosecution against the accused viz. Shafeeq Ahmad Sheikh, Mohammad Tariq Malik, Parvaiz Ahmad Turkhan and Ab. Hameed Sheikh, for the commission of offences as shown against each at Para (6), arising out of FIR No. 33/2024 of Police Station, Karnah.
