**NOTIFICATION**

Jammu, the 12th December, 2024

SO-571.— Whereas, on 30.07.2024, the Police Station, Poonch, received a docket to the effect that a reliable information was received about the deal/transportation of illegal arms/ ammunition across the border. Subsequently, a Joint Search Operation was launched by the Police/Security Forces in the general area of Mangnar forests. During the search, a suspect while seeing the Police/Security Forces tried to escape

but was chased down on the spot and identified as Mohammad Khalil Lone S/o Dawood Lone R/o Husangam, Gurez, Tulail, Bandipora. During his personal search, the Police recovered 01 Pistol with magazine and 08 rounds from his possession ; and

2. Whereas, based on the above, a Case FIR No. 142/2024 U/S 3/25 Arms Act and 16, 18, 20 of ULA (P) Act, was registered in the Police Station, Poonch, and the investigation, of the case was set into motion. Subsequently, during the investigation, the offence under Section 3/25 Arms Act and 16 of ULA (P) Act were dropped and the Section 7/25 Arms Act and 13, 23, 38 and 39 of ULA (P) Act, were added in the case ; and

3. Whereas, during the investigation, the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, the accused viz. Mohammad Khalil Lone, was found in contact with a Pak/PoK based terrorist of HM, a banned outfit, namely, Mian Zakir Hussain S/o Mian Ghulam Nabi R/o Ketson, Aloosa, Bandipora, through virtual mode, who provided the recovered arms/ ammunition to the accused viz. Mohammad Khalil Lone, through an unknown person in order to promote terrorism in the area. The identity/involvement of unknown person is yet to be ascertained and investigation, of the case shall continue and the Supplementary Charge Sheet against him would be filed in the court of competent jurisdiction ; and

5. Whereas, the investigation conducted by the investigating agency has *prima facie* established that the accused viz. Mohammad Khalil Lone, was working for the Pak/PoK based terrorist viz. Mian Zakir Hussain, and under a well knit criminal conspiracy procured arms/ammunition from the said terrorist through an unknown person for carrying out the terrorist/unlawful activities in the area ; and

6. Whereas, on the basis of the investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has established *prima facie* involvement of the below mentioned accused for the commission of offences punishable under sections of the Unlawful Activities (Prevention) Act, 1967 as shown against their names :—

7. Whereas, the accused PoK/Pak based terrorist viz. Main Zakir Hussain, is absconding and proceedings u/s 299 Cr.PC have been proposed to be initiated against him ; and

8. Whereas, the Authority appointed by the Government under sub-section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused ; and

9. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under sub- section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above mentioned accused for their prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 45 the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Khalil Lone and Mian Zakir Hussain, for the commission of offences punishable under the relevant sections of ULA (P) Act, as indicated against the each accused at Para (6) above, arising out of FIR No. 142/2024 of Police Station, Poonch.
