SO660. Whereas, on 08-02-2022, a reliable information was received by the Police Station, Bijbehara, to the effect that some miscreants identified as Muntazir Rashid Mir S/o Ab. Rashid Mir R/o Yanner, Pahalgam, Zahid Ahmad Najar S/o Najar Ahmad Najar, Fayaz Ahmad Khan S/o Gh. Hassan Khan, residents of Liver, Pahalgam, Adil Ahmad Tarray S/o Gh. Nabi Tarray, Mohd Azhar Dar S/o Muzafar

7. Whereas, during the investigation, the accused viz. Mohd Azhar Dar, has been found juvenile and in view of the Section 1(4) of the Juvenile Justice (Care and Protection of Child) Act, 2015, the apprehension, detention, prosecution, penalty or imprisonment shall be governed by the said Act ; and ;

8. Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused ; and

9. Whereas, after perusing the Case Diary File the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for their prosecution under the provisions of Law.

Now, therefore, in exercise of powers conferred by Sub-Section (2) of Section 45 of Unlawful Activities (Prevention) Act 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Muntazir Rashid Mir, Zahid Ahmad Najar, Fayaz Ahmad Khan, Adil Ahmad Tarray and Mohd Arif Khan, for commission
