SO-65.66-Whereas, on 26-02-2023, a reliable information was received by the Police Station, Litter, to the effect that at Village Achhan, Pulwama, some unknown terrorists fired

Sahil Bashir Dar, were arrested in the case and the accused viz. Nassir  
Farooq Shah, Towseef Ahmad Pandith and Shameem Ahmad Bhat @  
Uncle, were found already arrested by Anantnag/Shopian Police.  
Subsequently, their custody was also changed in the instant case and  
during the investigation, 01 Pistol magazine was recovered at the  
instance of accused viz. Nassir Farooq Shah ; and

6. Whereas, during the investigation, it was found that the accused  
viz. Nassir Farooq Shah, Shameem Ahmad Bhat @ Uncle, Aamir  
Hussain Wani, Towseef Ahmad Pandith, Sajad Ahmad Bhat @ Afnan  
Bhat, Sarjeel Zahoor Bhat and Sahil Bashir Dar, were in contact with  
the terrorists of LeT, a banned outfit, namely, @ Khalid Kamran, Zaffar  
Hussain Bhat @ Khurshid Kashmiri S/o Sonaulah Bhat R/o Liver, Sallar,  
Srigufwara, Danish Hamid Thoker S/o Abdul Hamid Thokar and Ubaid  
Ahmad Paddar S/o Wali Mohammad Paddar residents of Chakoora,  
Shopian, and were working for them in order to promote terrorist  
activities in the area ; and

7. Whereas, during the investigation, it was found that the accused  
viz. Aamir Hussain Wani, Nassir Farooq Shah, and Shameem Ahmad  
Bhat @ Uncle, on the directions of terrorists viz. @ Khalid Kamran,  
Zaffar Hussain Bhat @ Khurshid Kashmiri, Danish Hamid Thoker and  
Ubaid Ahmad Paddar, motivated one Jazim Farooq Wani @ Abrar  
S/o Farooq Ahmad Wani R/o Heff Sirmal, Shopian, to join the terrorist  
ranks of LeT, a banned outfit, and facilitated his joining with the said  
outfit ; and

8. Whereas, during the investigation, it was found that the  
accused viz. Nassir Farooq Shah and Aamir Hussain Wani, on the  
directions of Pakistan based terrorist viz. @ Khurshid Kashmiri,  
arranged a pistol and handed over the same to the accused viz.  
Jazim Farooq Wani @ Abrar, with the directions to kill the deceased  
Sanjay Kumar Sharma; and
