6. Whereas, during investigation, it was found that one accused
 viz. Umar Ishfaq Malik, after his release from the instant case joined
 the terrorist ranks of HM, a banned outfit, and later on has been killed
 in an encounter with the Security Forces and proceedings under the
 law would abate against him ; and

7. Whereas, on the basis of the investigation, the statements of
 witnesses recorded and other evidence collected, the Investigating
 Officer, has established *prima facie* involvement of the below mentioned
 accused for the commission of offences punishable in terms of the
 provisions of the Unlawful Activities (Prevention) Act, 1967, as shown
 against their names :
