SO676. In exercise of the powers conferred by Article 233 read with proviso to Article 309 of the Constitution of India, the Lieutenant Governor in consultation with the High Court of Jammu and Kashmir and Ladakh hereby make the following amendments in the Jammu and Kashmir Higher Judicial Service Rules, 2009 ; namely :

1. In rule 2(c), for the words "Common High Court of Jammu and Kashmir" the words "High Court of Jammu and Kashmir and Ladakh" shall be substituted.

2. In rule 18, in clause (i), the sign full stop (.) at the end shall be substituted by sign colon (:) and thereafter the following proviso shall be inserted :ô

∴Provided that w.e.f. 01-01-2020 there shall be 35% of the total number of posts in the cadre of the service carrying Selection Time Scale Payøø

3. In rule 19, in clause(i), the sign full stop (.) at the end shall be substituted by sign colon (:) and thereafter the following proviso shall be inserted :ô

∴Provided that w.e.f. 01-01-2020 there shall be 15% of the total number of posts in the cadre of District Judges carrying Super Time Scale of Payøø

4. In rule 25, after entry 3, the following proviso shall be inserted :ô

∴Provided that for the figure and sign ∴25%øø appearing in entry 2 and figure and sign ∴10% øø appearing in entry 3, the figure and sign ∴35%øø and ∴15%øø shall be substituted respectivelyøø

5. For Schedule-A, the following shall be substituted, namely :ô
