 search, the Police recovered four blank posters of TRF, a banned outfit,
 from his possession ; and

2. Whereas, based on the above, a Case FIR No. 132/2023 under
 Sections 13, 18 and 39 of ULA (P) Act, was registered in the Police
 Station, Khansahib, and the investigation, of the case was set into motion.
 Subsequently, during the investigation, the offence under Section 18 of
 ULA (P) Act as dropped from the case ; and

3. Whereas, during the course of investigation, the site plan of
 the place of occurrence and the seizure memos were prepared and
 the statements of witnesses acquainted with the facts and circumstances
 of the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, it was found that the accused
 viz. Zahoor Ahmad Want was working for some unknown terrorists
 of TRF, a banned outfit, who provided the incriminatory material to
 the accused viz. Zahoor Ahmad Wani, in order to promote terrorist
 activities in the area ; and

5. Whereas, during the investigation, it was established that the
 accused viz. Zahoor Ahmad Wani, was working as Over Ground Worker
 (OGW) for the terrorists of TRF, a banned outfit, and was
 providing logistic support to them, besides, procured incriminatory
 material from the terrorists for carrying out the unlawful activities in
 the area ; and

6. Whereas, on the basis of the investigation, the statements of
 witnesses recorded and other evidence collected, the Investigating
 Officer, has established a *prima facie* involvement of the below
 mentioned accused for the commission of offences punishable under
 Sections of the Unlawful Activities (Prevention) Act, 1967, as shown
 against his name :ô

7. Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that *prima facie* case is made out against the above accused ;

8. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for his prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Zahoor Ahmad Wani, for the commission of offences punishable under Sections 13 and 39 of ULA (P) Act, arising out of FIR No. 132/2023 of Police Station, Khansahib.
