Notification

Jammu, the 6th February, 2024.

SO-87.66-Whereas, on. 14-09-2023, the Police Station, Uri, received a docket to the effect that a reliable information was received about the movement of some unknown terrorists in the area. Subsequently, a Joint Search Operation was launched by the Police/Security Forces and during the checking, at Chatti Patshahi, Gurdwara Paranpillan, two

suspects while seeing the Police/Security Forces tried to escape but  
were chased down on the spot and identified as Mohammad Arif Channa  
S/o Nazir Ahmad Channa R/o Stadium Colony, Baramulla and Zaid  
Hassan Malla S/o Gh. Hassan Malla R/o Mohalla Mir Sahib, Baramulla.  
During search, the Police recovered 02 Pistols, 02 Magazines, 29 Rounds  
and 05 Chinese Hand Grenades respectively from the bags carried by  
the accused ; and

2. Whereas, based on the above, a Case FIR No. 108/2023 under  
Section 7/25 Arms Act and the Sections 13, 18, 23 and 39 of ULA  
(P) Act, was registered in the Police Station, Uri, and the investigation,  
of the case was set into motion ; and

3. Whereas, during the course of investigation, the site plan of  
the place of occurrence and the seizure memos were prepared and  
the statements of witnesses acquainted with the facts and circumstances  
of the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, one more person  
identified as Aftar Ahmad Lohar S/o Mohd Maqbool Lohar R/o Bair,  
Ward No. 1, Fazalabad, Surankote, Poonch, was found involved in  
the case. Subsequently, the accused was arrested and during the  
investigation, 01 Pistol with Magazine and 04 Rounds were recovered  
at his instance ; and

5. Whereas, during the investigation, it was found that the accused  
viz. Mohammad Arif Channa, Zaid Hassan Malla and Aftar Ahmad  
Lohar, were in contact with a Pakistani based terrorist of LeT, a banned  
outfit, through virtual mode, who provided the recovered arms/  
ammunition and hand grenades to them through an unknown person  
in order to promote terrorist activities in the area ; and

6. Whereas, during the investigation, it was established that the  
accused viz. Mohammad Arif Channa, Zaid Hassan Malla and Aftar  
Ahmad Lohar, were working as Over Ground Workers (OGWs), for  
the terrorists of LeT, a banned outfit, and were providing logistic support  
to them, besides, under a well knit criminal conspiracy procured arms/  
ammunition and hand grenade from the terrorists through an unknown  
person for carrying out the terrorist/unlawful activities in the area ; and

7. Whereas, the investigation, in respect of other accused who  
provided the arms/ammunition and hand grenades to the accused viz.
