Jammu, the 4th January, 2024.

SO-9.66-Whereas, on 03-03-2023, the Police Station, Mandi,  
received a docket to the effect that a Joint Search Operation was

launched by the Police/Security Forces in Sathra Gali Pindi, Dana  
Doiyan, Mandi, area and during the search operation, a reliable  
information was received that one person identified as Mohd Rafi @  
Rafi S/o Late Sher Mohd R/o Danna Doiyan, Teshil Mandi, District  
Poonch, having links with Pakistani ISI, has concealed some arms/  
ammunition and cash in his residential house. Subsequently, a search  
was carried out and during the search, the Police recovered 07 Packets  
of narcotic like substance, 05 bags containing cash of Indian currency  
which could not counted for, 01 Pistol with magazine, 10 pistol rounds,  
07 SLR rounds, 07 Mobile Phones and 05 SIM cards from his residential  
house ; and

2. Whereas, based on the above, a Case FIR No. 18/2023 under  
Sections 8(a)/21 NDPS Act, 4/25, 7/25 Arms Act, and the Sections  
13, 17, 21 & 39 of ULA (P) Act, was registered in the Police Station,  
Mandi, and the investigation, of the case was set into motion.  
Subsequently, during the investigation, the offences under Section 22  
NDPS Act, 489-C IPC and the Section 18 of ULA (P) Act were  
added in the case ; and

3. Whereas, during the course of investigation, the site plan of  
the place of occurrence and the seizure memos of recovered ammunition  
and cash to the tune of Rs. 2,30,07,400/- and 15000 USD American  
Dollars were prepared and the statements of witnesses acquainted with  
the facts and circumstances of the case were recorded under the  
relevant provisions of law ; and

4. Whereas, during the investigation, it was found that the accused  
viz. Mohd Rafi @ Rafi, was already arrested by the Poonch Police  
and was detained under the provisions of J&K Public Safety Act, 1978.  
Subsequently, his custody was changed in the instant case and it was  
found that the accused was in contact with some Pakistani based  
terrorist organizations/ISI agents through virtual mode, who provide the  
recovered ammunition and narcotic substances to the accused viz. Mohd  
Rafi @ Rafi, in order to sell the same so that the money generated  
could be utilized to commit terrorist activities ; and

5. Whereas, during the investigation, it was found that the accused  
viz. Mohd Rafi @ Rafi. was also in contact with some Punjab based
