Srinagar, the 17th May, 2016.

SRO-151.—Whereas, on 10-10-2012, SHO, Police Station, D. H. Pora, District Kulgam along with Nafri of Police Station, CRPF 18 Bn. and 62 RR were performing Naka duty in DH Pora. During checking one Alto Car bearing Regd. No. JK16/1721 coming from Nandimarg to D. H. Pora was stopped. On search of the said vehicle, three persons namely (1) Mohammad Yousuf Magray S/o Abdul Gani R/o Lassipora, Pulwama, (2) Shabir Ahmad Magray S/o Gh. Nabi Magray R/o Nowgam Payee and (3) Abid Manzoor S/o Manzoor Ahmad Magray R/o Nowgam were found in the vehicle and during search of the said vehicle, one hand grenade,

01 Pistol, 01 Magazine and 10 rounds were recovered from one of the arrested person namely, Mohammad Yousuf Magray ; and

Whereas, on preliminary questioning, the said person disclosed that he is a terrorist of banned HM outfit and other two accused persons were also involved in terrorist activities ; and

Whereas, in this connection, Case FIR No. 105/2012 under sections 13 and 20 of the Unlawful Activities (Prevention) Act, 1967 and 7/25 Arms Act was registered in Police Station, D. H. Pora and investigation initiated ; and

Whereas, during the course of investigation, on the basis of statement of witnesses, the seizure memo and other evidence, the Investigating Officer has established a *prima facie* case against the accused persons under sections 13 and 20 of the Unlawful Activities (Prevention) Act, 1967 apart from other offence ; and

Whereas, the Authority appointed by the State Government under sub-section (2) of section 45 of the Unlawful Activities (Prevention) Act, 1967 has independently scrutinized the Case Diary file and all the other relevant documents relating to the case and has come to a definite conclusion that this is a fit case for accord of prosecution sanction against the accused persons ; and

Whereas, after perusing the Case Diary, the relevant documents and also taking into consideration the observations/views of the Authority appointed under sub-section (2) of section 45 of the Unlawful Activities (Prevention) Act, the State Government is of the view that there is sufficient material and evidence available against the accused persons for their prosecution under the aforesaid provisions of law.

Now, therefore, in exercise of powers conferred by sub-section (1) of section 45 of the Unlawful Activities (Prevention) Act, 1967, the State Government hereby accords sanction for launching prosecution against the below mentioned accused persons for the commission of offence punishable

under sections 13 and 20 of the Unlawful Activities (Prevention) Act, 1967, arising out of FIR No. 105/2012 of Police Station, D. H. Pora, District Kulgam :—

- (1) Mohammad Yousuf Magray S/o Abdul Gani R/o Lassipora, Pulwama.
- (2) Shabir Ahmad Magray S/o Gh. Nabi Magray R/o Nowgam Payee.
- (3) Abid Manzoor S/o Manzoor Ahmad Magray R/o Nowgam.
