Jammu and Kashmir Government—Notifications.

GOVERNMENT OF JAMMU AND KASHMIR CIVIL SECRETARIAT—HOME DEPARTMENT

Notification

Srinagar, the 13th October, 2016.

SRO-331.—Whereas, on 13-09-2010, during the maintenance of law and order situation in Khanabal area, some youth including Maroof Ahmad Nath @ Raju while fleeing jumped into River Jehlum and the said Maroof Ahmad Nath drowned in the river. The body of said person was recovered on 18-09-2010 and was carried in the shape of a procession towards Khanabal, then to KP Road and finally towards Delhi Darbar. However, when the procession was stopped from entering Anantnag Town, as restrictions were imposed in that areas, the miscreants resorted to heavy stone pelting and the mob turned violent, resultantly, few shots were, reportedly, fired in air to control the mob, due to which some persons got injured and the procession returned towards Khanabal via Nai Basti. Out of the injured, two persons Bilal Ahmad Najar and another person Noor-ul-Amin Dagga succumbed to their injuries; and

Whereas, with regard to the aforementioned firing incident near Delhi Darbar, case FIR No. 355/2010 was registered in Police Station, Anantnag; and

Whereas, subsequently father of one of the aforementioned deceased person approached the Hon'ble Court for registration of a separate case, with the plea that the deceased persons were injured in the firing incident near Ahali Hadees Masjid, Khanabal and not near Delhi Darbar; and

Whereas, in this connection, a separate case FIR No. 361/2012, under section 302 RPC was registered at Police Station, Anantnag, after judicial intervention with the further direction to constitute a Special Investigation Team, and as such investigating was initiated ; and

Whereas, during the course of investigation, conducted by Special Investigation Team constituted in the matter, statement of witnesses was recorded and as many as 27 independent witnesses namely Dy. SP, Noor-ul-Hassan Parray as accused in the said case, highlighting his role in the said incident that had taken place near Ahali Hadees Masjid, Khanabal and the details regarding the deployment of nafree, that was obtained from concerned agencies by the Investigating Officer, also corroborated the fact of posting of the accused in the said area on the date of incident ; and

Whereas, during the course of investigation, on the basis of the statements of witnesses, the seizure memos and other evidence, the Investigating Officer has established, *prima facie*, a case under section 304-II of RPC against the accused ; and

Whereas, the appointing authority of Noor-ul-Hassan Parray (Dy. SP) is the Government in the Home Department and the offence has been committed by the accused person while acting or purporting to act in discharge of his official duties and to prosecute him, sanction under section 197 (1) J&K, Cr. P. C. is mandatory.

Now, therefore, in exercise of the powers conferred by subsection (1) of section 197 of the Code of Criminal Procedure, Svt. 1989, the State Government hereby accords sanction for launching prosecution against the accused person namely, Noor-ul-Hassan Parray (Dy. SP) S/o Gh. Hassan Parray R/o Brinal, Lammer for the commission of offence punishable under section 304-II RPC, arising out of FIR No. 361/2012 of Police Station, Anantnag.
