GOVERNMENT OF JAMMU AND KASHMIR GENERAL ADMINISTRATION DEPARTMENT

Notification

Jammu, the 4th February, 2016.

SRO-34.—In pursuance of section 2 of the Jammu and Kashmir Delegation of Powers Act, 2016 (Governor's Act No. 1 of 2016), the Governor is pleased to direct that—

(i) In respect of the departments allocated to Advisors vide Notification SRO-33 of 2016 dated 4th February, 2016, all cases which are required to be submitted to the Cabinet in terms of Schedule-II of the Jammu and Kashmir Government Business Rules shall be submitted by the Administrative Departments with the approval of the concerned Advisor to the State Administrative Council through the Chief Secretary ;

- (ii) in respect of the departments allocated to Advisors vide Notification SRO-33 of 2016 dated 4th February, 2016, all cases which are required to be submitted to the Chief Minister in co-ordination or the Governor in terms of Schedule-III and Schedule-IV of the Jammu and Kashmir Government Business Rules shall be submitted by the Administrative Department concerned with the prior approval of the concerned Advisor to the Governor through Chief Secretary ;
- (iii) in respect of departments indicated in Appendix-A to this notification, all matters including those listed in Schedule-II, Schedule-III and Schedule-IV of Jammu and Kashmir Government Business Rules shall be submitted to the State Administrative Council or the Governor, as the case may be, with the prior approval of the Chief Secretary;
- (iv) in respect of departments indicated in Appendix-B to this notification, all matters including those listed in Schedule-II, Schedule-III and Schedule-IV of Jammu and Kashmir Government Business Rules shall be submitted to the State Administrative Council or the Governor, as the case may be, with the prior approval of the Financial Commissioner, Planning and Development Department though Chief Secretary; and
- (v) the powers already delegated to the Administrative Secretaries as notified vide Notification SRO-10 of 2016 dated 14th January, 2016 shall continue to be exercised by them.
