Notification

Jammu, the 22nd March, 2016.

SRO-95.—Whereas, on 03-09-2011, Police Station, Bandipora received a reliable information that some youth are provoking the general public especially youth of the area and instigating them against the established Govt./Security Forces. During enquiry, it transpired that a complaint was filed by 14 RR, Camp Kharpora (Gundpora), Bandipora before Station

House Officer, Police Station, Bandipora alleging therein that during the search operations at Khanpora, Bandipora, they have apprehended one Mohammad Ramzan Khan S/o Gh. Nabi Khan R/o Khanpora affiliated with Peoples Freedom League who was found indulging in anti-national activities. The accused was arrested. The said accused during interrogation, admitted that he along with one Ferooz Ahmad Bhat @ Asif S/o Noor Mohammad Bhat R/o Alastang, Shuhama, Ganderbal was indulging in activities which are detrimental to the security of the State and Union of India ; and

Whereas, in this connection, Case FIR No. 195/2011, under sections 10 and 13 of the Unlawful Activities (Prevention) Act, 1967, was registered in Police Station, Bandipora and investigation initiated ; and

Whereas, during the course of investigation, on the basis of statements of witnesses, the seizure memo and other evidence, the Investigating Officer has established a *prima facie* case against the accused persons under sections 10 and 13 of the Unlawful Activities (Prevention) Act, 1967 ; and

Whereas, the Authority appointed by the State Government under sub-section (2) of section 45 of the Unlawful Activities (Prevention) Act, 1967 has independently scrutinized the Case Diary file and all other relevant documents relating to the case and has come to a definite conclusion that this is a fit case for accord of prosecution sanction against the accused persons ; and

Whereas, after perusing the Case Diary, the relevant documents and also taking into consideration the observations/views of the Authority appointed under sub-section (2) of section 45 of the Unlawful Activities (Prevention) Act, 1967, the State Government is of the view that there is sufficient material and evidence available against the accused persons for their prosecution under the aforesaid provisions of law.

Now, therefore, in exercise of powers conferred by sub-section (1) of section 45 of the Unlawful Activities (Prevention) Act, 1967, the State Government hereby accords sanction for launching prosecution against the

below mentioned accused persons for the commission of offence punishable under sections 10 and 13 of the Unlawful Activities (Prevention) Act, 1967, arising out of FIR No. 195/2011 of Police Station, Bandipora :—

- (1) Mohammad Ramzan Khan S/o Gh. Nabi Khan R/o Khanpora (Gundpora), Bandipora.
- (2) Ferooz Ahmad Bhat @ Asif S/o Noor Mohammad Bhat R/o Alastang, Shuhama, Ganderbal.
