SO.-179.66-In exercise of powers conferred by Sectio 93 of the Jammu and Kashmir Reorganization Act, 2019, and SO.-3937 (E) dated 31st October, 2019, read with Order issued in terms of sub-clause (i) of clause (c) of the Proclamation issued by the President dated 31st

- - (i) A person appointed to be Chairman of the Public Service Commission for the Union Territory of Jammu and Kashmir shall, before he/she enters upon his/her office, make and subscribe before the Lieutenant Governor of Union Territory of Jammu and Kashmir, or some person appointed in that behalf by him, an oath or affirmation according to Form-I annexed to this notification.
