Article 309 of the Constitution of India and in supersession of all rules/

orders on the subject, the Lieutenant Governor is pleased to direct the
following amendments in the Jammu and Kashmir Special Recruitment
Rules, 2015, namely :ô

1. *Short title and commencement.*ô (1) These rules may be
called the Jammu and Kashmir Special Recruitment (Amendment)
Rules, 2020.

(2) It shall come into force with immediate effect.

2. In rule 8 of the Jammu and Kashmir Special Recruitment
Rules, 2015 (hereinafter referred to as the "said rules"), in sub-rule (1),
for "five years" substitute "two years" wherever occurring ;

3. In rule 9 of the said rules in sub-rules (1) and (2), for the words
"five years" substitute "two years" wherever occurring ;

4. In rule 10 of the said rules, in sub-rule (1), for the words "five
years service" substitute "two years services" ;

5. After rule 12 of the said rules, following rules shall be added,ô

ô13. **No monetary benefit as a result of amendments
made by the Jammu and Kashmir Special
Recruitment (Amendment) Rules, 2020 before
1-7-2020.**— Any person appointed under these rules
before 1-7-2020 shall be governed by provisions of rules
8, 9 and 10, as amended by the Jammu and Kashmir
Special Recruitment (Amendment) Rules, 2020, subject to
the condition that ;

(a) Such persons, who have completed probation
prior to 1-7-2020 as per the amendments made by
the Jammu and Kashmir Special Recruitment
(Amendment) Rules, 2020, shall be entitled to
notional benefit only upto 30-6-2020 and monetary
benefit with effect from 1-7-2020.

(b) Such persons, who complete their probation
after 1-7-2020 as per the amendments made by the

Jammu and Kashmir Special Recruitment (Amendment) Rules, 2020, shall be entitled to monetary benefit from the date of completion of such probation ; and

(c) Before getting any benefit under amended rules, an appointee under these rules has to furnish an undertaking in such form as may be prescribed by the General Administration Department that he agrees to the change in terms of his appointment failing which he will continue to be governed by the original terms of his appointment.

14.No appointment under these rules.ö After coming into force of the Jammu and Kashmir Special Recruitment (Amendment) Rules, 2020, no fresh appointment shall be made these rules.ö
