## Notification

Jammu, the 18th January, 2022.

SO-20.66 Whereas, on 24-07-2021, Anantnag Police received reliable information that one Molvi of Hanfiya Jamia Masjid Khanabal Gh. Mohammad Khaki S/o Mohammad Ramzan R/o Kadipora Anantnag delivered a speech on the occasion of Eid-ul-Azha in which he made allegations that Kashmiri people are the victims of security forces who

are setting ablaze houses of Kashmiries without any reason/justification.  
The accused provoked the public against the sovereignty and integrity  
of India ; and

2. Whereas, a Case FIR No. 338/2021 u/s 13 Unlawful Activities  
(Prevention) Act 1967, came to be registered in Police Station, Anantnag  
and investigation of the case was set into motion ; and

3. Whereas, during the course of investigation, site plan of place  
of occurrence was prepared and statements of witnesses acquainted with  
the facts and circumstances of the case were recorded under the relevant  
provisions of law ; and

4. Whereas, during the investigation, accused Gh. Mohammad  
Khaki was arrested in connection with the case and it was established  
that on 24-07-2021 accused delivered objectionable speech during the  
Eid prayers and instigated the general public against the accession of  
J&K with Union of India, thereby caused threat to sovereignty and  
integrity of India ; and

5. Whereas, on the basis of investigation, statements of witnesses  
recorded and other evidence collected, the Investigating Officer has  
established *prima facie* involvement of below mentioned accused person  
in commission of offence punishable under section as shown against his  
name of Unlawful Activities (Prevention) Act, 1967 :ô

6. Whereas, the Authority appointed by the Government under  
sub-section (2) of Section 45 of the Unlawful Activities (Prevention)  
Act, 1967 has independently examined the case diary file and all the  
other relevant documents relating to the case and has come to the  
conclusion that a *prima facie* case is made out against the above accused  
person ; and

7. Whereas, after perusing the Case Diary File, the relevant  
documents and also taking into consideration the views of the authority

appointed under sub-section (2) of Section 45 of the Unlawful Activities  
(Prevention) Act, 1967, the Government is of the view that there is  
sufficient material and evidence available against the above-mentioned  
accused person for his prosecution under the provisions of law.

Now, therefore, in exercise of powers conferred by sub-section (2)  
of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the  
Government hereby accords sanction for launching prosecution against  
the above-mentioned accused for the commission of offence punishable  
under Section 13 ULA (P) Act, in case FIR No. 338/2021 of Police  
Station, Anantnag.
