#### Jammu, the 20th January, 2022.

SO-23.óóWhereas Ajay Kumar Sharma S/o Bansi Lal Sharma R/o Near Durga Mandir, Gangyal Jammu, J&K-180010 has filed an application under Section 17(1) of the Working Journalists and Other Newspaper Employees (Conditions of Service) and Miscellaneous Provisions Act, 1955 before the Labour Commissioner (Authority, Working Journalists Act, 1955) on 23-03-2021 against the management-(1) Managing Director, M/s Amar Ujala Ltd. New Delhi (2) Branch

Whereas, both the parties were heard by the Labour Commissioner and the matter could not be resolved between the parties and has now requested that the payment of claimed amount is required to be adjudicated by the J&K Industrial Tribunal/Labour Court in terms of Section 17(2) of the Working Journalists and Other Newspaper Employees (Conditions of Service) Act, 1955, constituted under Section 7 of the Industrial Disputes Act, 1947 (14 of 1947) ; and

Whereas, the Labour Commissioner has recommended the case for its reference under sub-section (2) of Section 17 of the Working Journalists and Other Newspaper Employees (Conditions of Service) and Miscellaneous Provisions Act, 1955 to the Honøble Industrial Tribunal/ Labour Court, Jammu constituted under Section 7 of the Industrial Disputes Act, 1947 (14 of 1947) for adjudication ; and

Whereas, the Government considers it desirable to refer the said dispute to the Industrial Tribunal/Labour Court, Jammu for adjudication.

Now, therefore, in exercise of the powers conferred under clause (c) of sub-section (1) of Section 10 of the Industrial Dispute Act, 1947 (XIV of 1947), the Government hereby refers the said dispute to the Industrial-Cum-Labour Court, Jammu for adjudication on the following issues :ô

1. Whether the claimant is covered under the definition of Working Journalists and Non-journalist employee as defined in Working Journalists and other Newspaper Employees (Conditions of Service) and Miscellaneous Provisions Act, 1955 ? 2. Whether the claimant is entitled for claim as per the recommendations of the Majithia Wage Board, if yes, then to what extent ?
