Srinagar, the 21st June, 2022.

SO-299.66 Whereas, on 11-07-2019, Police Station, Kakapora received a written docket to the effect that during the investigation of a missing person namely, Aijaz Ahmad Bhat S/o Ali Mohammad Bhat R/o Laribal, Kakapora, who has left home on 18-06-2019, has been found to have joined the Lashkar-e-Toiba (LeT), a banned terrorist outfit. The said person viz. Aijaz Ahmad Bhat, has also uploaded his photograph

with illegal arms/ammunition on social media showing his allegiance with
the banned LeT outfit and is actively taking part in subversive activities
to cause harms to the sovereignty and integrity of India ; and

2. Whereas, a Case FIR No. 40/2019 under section 20 of ULA
(P) Act and 121 RPC, was registered in Police Station, Kakapora and
investigation of the case was taken up. Subsequently, during investigation
Section 212 RPC, Sections 18, 18-B and 39 of ULA (P) Act were added
in the case ; and

3. Whereas, during the course of the investigation, statements of
witnesses acquainted with the facts and circumstances of the case were
recorded under the relevant provisions of law ; and

4. Whereas, during the further investigation, it was found that the
accused viz. Aijaz Ahmad Bhat, was recruited by one Ayaz Bashir
Shergojri S/o Bashir Ahmad Shergojri R/o Marvel, Kakapara to join the
terrorist ranks of Lashkar-e-Toiba (LeT). Subsequently, the said accused
viz. Ayaz Bashir Shergojri, was arrested in the case ; and

5. Whereas, during investigation, it was established that the accused
viz. Ayaz Bashir Shergojri, was working as Over Ground Worker (OGW)
for the terrorists of LeT banned outfit particularly terrorist Aijaz Ahmad
Bhat and under a well knit criminal conspiracy, was providing shelter/
logistic support to them, besides, facilitated the joining of the accused
viz. Aijaz Ahmad Bhat with the LeT banned outfit ; and

6. Whereas, the terrorist viz. Aijaz Ahmad Bhat has been killed
in an encounter with the Security Forces and proceedings under the law
would abate against him ; and

7. Whereas, on the basis of the investigation, the statement of
witnesses recorded and other evidence collected, the Investigating Officer
has established a *prima facie* involvement of the below mentioned
accused for the commission of offences punishable under sections of
the Unlawful Activities (Prevention) Act, 1967, as shown against his
names :ô

8. Whereas, the Authority appointed by the Government under sub-section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused ; and

9. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under sub-section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for his prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Ayaz Bashir Shergojri for the commission of offences punishable under sections 18, 18-B and 39 of ULA (P) Act, arising out of FIR No. 40/2019 of Police Station, Kakapora.
