Notification

Srinagar, the 18th July, 2022.

S.O.-336.& Whereas, on 25-03-2019, the Police Station, Hajin received an information through reliable source to the effect that a number of persons associated with the banned J&K Liberation Front (Mohammad Yaseen Malik), continue to be the members of the banned association and were carrying out the unlawful activities which is prejudicial to the security, territorial integrity and sovereignty of the Union of India ; and

2. Whereas, based on the above, a case FIR No. 11/2019 under Sections 10, 13 of ULA (P) Act, 1967, came to be registered in Police Station, Hajin and the investigation of the case was taken up ; and

3. Whereas, during the course of investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statement of the witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

5. Whereas, on the basis of investigation, statement of witnesses recorded and other evidence collected, the Investigating Officer has established *prima facie* involvement of below mentioned accused in the commission of offences punishable under Unlawful Activities (Prevention) Act, 1967, as shown against his name :ô

6. Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused ; and

7. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for his prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution
