S.O.-414.ô Whereas, on 07-03-2022, the Police Station, Panzalla, received a docket to the effect that a reliable information was received regarding the movement of some unknown terrorists at Gulshan Colony, Nadihal, conspiring to carry out terrorist activities in the area. Subsequently, a Joint Cordon and Search Operation was launched by

2. Whereas, based on the above, a Case FIR No. 16/2022 under Sections 7/25 Arms Act, 13, 18, 38 of ULA (P) Act, was registered in the Police Station, Panzalla, and the investigation of the case was taken up. Subsequently, during the investigation, Section 18 of ULA (P) Act was dropped and Section 23 of ULA (P) Act, was added in the case ; and

3. Whereas, during the course of investigation, the site plan of the place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and

4. Whereas, during the investigation, the accused viz. Firdous Ahmad Wani, was associate of terrorist organization, LeT banned outfit, who procured the arms/ammunition from the terrorists of the said outfit, for carrying out the terrorist activities in the area ; and

5. Whereas, on the basis of the investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has established *prima facie* involvement of the below mentioned accused for the commission of offences punishable under sections of the Unlawful Activities (Prevention) Act, 1967, as shown against his name : \hat{o}

Whereas, the Authority, appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the 7. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for his prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Firdous Ahmad Wani, for the commission of offences punishable under Sections 13, 23 and 38 of ULA (P) Act, arising out of FIR No. 16/2022 of Police Station, Panzalla.
