Notification

Jammu, the 2nd February, 2022.

- S.O.-46.ô Whereas, on 10-8-2021, some unknown terrorists lobbed a grenade upon the security forces at Hari Singh High Street, Srinagar which exploded on road, resulting in injuries to ten pedestrians. During attack security forces chased down one accused identified as Adil Farooq Bhat S/o Farooq Ahmad R/o Khrew and recovered 02 hand grenads from his possession However, two other accused persons escaped from spot; and
- 2. Whereas, a Case FIR No. 84/2021, 307 IPC, 3/5 Explosive Substances Act, came to be registered in Police Station Shaheed Gunj

- 3. Whereas, during the course of investigation, site plan of place of occurrence and seizure memos were prepared and statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during investigation, the other involved accused person namely Imran Nazir Najar @ Zahid S/o Nazir Ahmad R/o Mandakpal Khrew was arrested in connection with the case and during investigation both thhe accused persons disclosed that they were working for JeM banned outfit and on the date of occurrence both the accused persons alongwith one known terrorist of the outfit lobbed hand grenade upon the security forces at Hari Singh High Street with intention to kill the officials; and
- 5. Whereas, during investigation, it was established that the accused persons Adil Farooq Bhat and Imran Nazir were associated with the terrorist organization JeM with intention to carry out terroist activities and under well knit criminal conspiracy hurled hand grenade upon the security forces at Hari Singh High Street, wich resulted injuries to 10 pedestrians; and
- 6. Whereas, on the basis of investigation, statements of witnesses recored and other evidence collected, the Investigating Officer has established *prima facie* involvement of below mentioned accused persons for the commission of offences punishable under section as shown agains each of Unlawful Activities (Prevention) Act, 1967:ô
- 1 Adil Farooq Bhat S/o Farooq Ahmad 13, 16, 18, 38 R/o Khrew Pampore. ULA(P) Act
- Imran Nazir Najar @ Zahid S/o Nazir Ahmad R/o Mandakpal Khrew.
- 7. Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act,1967 has indepently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion

8. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above mentioned accused persons for their prosecution under the provisions of law.

Now therefore, in exercise of powers conferred by Sub-Section (2) of Section 45 Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the above accused persons for the commission of offences punishable under Sections 13, 16, 18, 38 of Unlawful Activities (Prevention) Act, 1967, in the case FIR No. 84/2021 of Police Station Shaheed Gunj.
