Jammu and Kashmir Government—Notifications.

Srinagar, the 28th September, 2022.

S.O.-461.ô Whereas, on 06-08-2020, the Police Station, Doda, received a reliable information to the effect that two persons identified as Sheraz Ahmad Malik S/o Rustam Malik and Tanveer Ahmad Malik S/o Ghulam Ahmed Malik R's/o Rai, Doda, slaughtered a Cow and took the photographs of the legs of slaughtered cow and shared/post the same on

the social media, with common and criminal intention to hurt the sentiments
of the Hindu Community residing in the area ; and

2. Whereas, upon this information. a Case FIR No. 140/2020 under
section 295-A, IPC was registered in Police Station, Doda and investigation
of the case was set into motion. Subsequently, during the investigation
Section 201 IPC was added in the case ; and

3. Whereas, during the course of investigation, the site plan of the
place of occurrence and the seizure memos were prepared and the
statements of witnesses acquainted with the facts and circumstances of
the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, the accused viz. Sheraz Ahmad
Malik and Tanveer Ahmad, were arrested in the case and it was established
that the accused purchased one Calf from an unknown Gujjar and slaughtered
the same. The accused clicked some photographs of the legs of slaughtered
Calf and shared/post the same on the social media, with intention to hurt
the sentiments of Hindu Community residing in the area ; and

5. Whereas, on the basis of investigation, statement of witnesses
recorded and other evidence collected, the Investigating Officer has
established *prima facie* involvement of below mentioned accused for the
commission of offences punishable under section as shown against each of
IPC :

S. No.	Name of the accused	Offence
1.	Sheraz Ahmad Malik S/o Rustam Malik R/o Rai, Doda.	295-A, IPC
2.	Tanveer Ahmad Malik S/o Ghulam Ahmed Malik R/o Rai, Doda.	

6. Whereas, the Government has independently examined the Case
Diary File and all the other relevant documents relating to the case and has
come to the conclusion that *prima facie* case is made out against the above
accused under the aforementioned provisions of IPC ; and

7, Whereas, after perusing the Case Diary File, the relevant
documents and also taking into consideration the views of the Authority,

the Government is of the view that there is sufficient material and evidence
available against the above-mentioned accused for their prosecution under
the provisions of law.

Now, therefore, in terms of Section 196 Cr. PC, the Government
accord sanction for launching prosecution against the above accused viz.
Sheraz Ahmad Malik and Tanveer Ahmad Malik, for the commission of
offence punishable under Section 295-A of IPC, arising out of FIR No.
140/2020 of Police Station, Doda.
