## Notification

Srinagar, the 6th October, 2022.

SO-476.66 Whereas, on 26-04-2022, the Police Station, Pattan received a docket to the effect that a reliable information was received that some unknown terrorists are travelling in a vehicle towards Srinagar for carrying out the terrorist activities. Subsequently, the Joint Nakas were established in the area and during the Naka Checking at Hanjiwara, Police intercepted a vehicle for checking. The driver of the vehicle along with his accomplice while seeing the Naka Party tried to escape but were chased down on the spot and identified as Mohd Aquib Mir

the Police recovered 02 Chinese Pistols, 02 Magazines, 10 Rounds and  
02 hand grenades from their possession respectively ; and

2. Whereas, based on the above, a Case FIR No. 129/2022 under  
Sections 7/25 Arms Act, 20, 38 of ULA (P) Act, was registered in the  
Police Station, Pattan and the investigation of the case was set into  
motion. Subsequently, during the investigation Sections 18, 23 of ULA  
(P) Act and Section 120-B IPC were added in the case ; and

3. Whereas, during the course of investigation, the site plan of the  
place of occurrence and the seizure memos were prepared and the  
statements of witnesses acquainted with the facts and circumstances of  
the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, the accused viz. Mohd Auqib  
Mir and Danish Ahad Dar, were found affiliated with the some unknown  
terrorists of the outfit, who provided arms/ammunition to the accused  
in order to promote terrorist activities in the area ; and

5. Whereas, during the investigation, it was established that the  
accused viz. Mohd Auqib Mir and Danish Ahad Dar, were members  
of JeM banned outfit and under a well knit criminal conspiracy procured  
arms/ammunition from the terrorists of the said outfit for carrying out  
the terrorist activities in the area ; and

6. Whereas, on the basis of the investigation, the statement of  
witnesses recorded and other evidence collected, the Investigating Officer,  
has established *prima facie* involvement of the below mentioned accused  
for the commission of offences punishable under sections of the Unlawful  
Activities (Prevention) Act, 1967, as shown against their name :ô

7. Whereas, the Authority, appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused ; and

8. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for their prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Mohd Auqib Mir and Danish Ahad Dar, for the commission of offences punishable under Sections 18, 20, 23 and 38 of ULA (P) Act, arising out of FIR No. 129/2022 of Police Station, Pattan.
