SO-478.66 Whereas, on 17-05-2022, the Police Station, Baramulla received a reliable informatton that some unknown terrorists lobbed a hand grenade inside the newly opened Wine Shop at Deewan Bagh, Baramulla, resulting in on spot injuries to four employees working in the said Wine Shop, who were shifted to hospital for treatment ; and

2. Whereas, based on the above, a Case FIR No. 84/2022 under Sections 307 IPC, 3/4 ESA, 16 of ULA (P) Act, was registered in the

 Worker (OGW) for the above terrorists and was providing logistic support to them, besides, the accused viz. Mohammad Maroof Soleh @ Adil and Faisal Shaban Gojri under a well knit criminal conspiracy hurled the hand grenade upon the Wine Shop at Deewan Bagh, Baramulla on 17-5-2022, which resulted in the death of deceased Ranjeet Singh, who was working in the said Wine Shop. The accused viz. Mohammad Maroof Soleh @ Adil, Faisal Shaban Gojri and Hatif Ahmad Sofi, were also harbouring the terrorists of LeT banned outfit for carrying out the terrorist activities in the area ; and

7. Whereas, the investigation, in respect of PoK based terrorist namely Mohammad Iqbal, and two unknown persons who provided arms/ammunition to accused viz. Shahid Showkat Bala, shall continue to ascertain their identity and to bring out their role/involvement in the case ; and

8. Whereas, on the basis of the investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has established *prima facie* involvement of the below mentioned accused for the commission of offences punishable under sections of the Unlawful Activities (Prevention) Act, 1967, as shown against their name :ô
