## Notification

Srinagar, the 6th October, 2022.

SO-480.66Whereas, on 23-10-2019, the Police Station, Manzgam received a docket to the effect that some unknown miscreants have pasted intimidating posters of Tehreek Taliban, Kashmir (TTK) on the electric poles in market Manzgam, thereby threatened the general public/school teachers for closing the market/schools in the area ; and

2. Whereas, based on the above, a Case FIR No. 57/2019 under Section 13 of ULA (P) Act, was registered in the Police Station, Manzgam

and the investigation of the case was set into motion. Subsequently, during  
the investigation Section 506 IPC was added in the case ; and

3. Whereas, during the course of investigation, the site plan of the  
place of occurrence and the seizure memos were prepared and the  
statements of witnesses acquainted with the facts and circumstances of  
the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, one Aamir Hassan Thoker  
S/o Gh. Hassan Thoker R/o Check Watoo, was found involved in the  
commission of crime. Subsequently, the accused was arrested and it was  
established that on 23-10-2019, the accused viz. Aamir Hassan Thoker,  
pasted the poster of Tehreek Taliban, Kashmir (TTK) on the electric  
pole in Market Manzgam, thereby threatened the general public and  
school teachers for closing of market and schools in order to carry out  
unlawful activities against the sovereignty, integrity and security of  
India ; and

5. Whereas, on the basis of the investigation, the statement of  
witnesses recorded and other evidence collected, the Investigating Officer,  
has established *prima facie* involvement of the below mentioned accused  
for the commission of offences punishable under section of the Unlawful  
Activities (Prevention) Act, 1967, as shown against his name :ô

6. Whereas, the Authority, appointed by the Government under  
Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention)  
Act, 1967, has independently examined the Case Diary File and all the  
other relevant documents relating to the case and has come to the  
conclusion that a *prima facie* case is made out against the above  
accused ; and

7. Whereas, after perusing the Case Diary File, the relevant  
documents and also taking into consideration the views of the Authority  
appointed under Sub-Section (2) of Section 45 of the Unlawful Activities  
(Prevention) Act, 1967, the Government is of the view that there is

sufficient material and evidence available against the above-mentioned  
accused for his prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-  
Section (2) of Section 45 of the Unlawful Activities (Prevention)  
Act, 1967, the Government hereby accord sanction for launching  
prosecution against the accused viz. Aamir Hassan Thoker, for the  
commission of offence punishable under Section 13 of ULA (P) Act,  
arising out FIR No. 57/2019 of Police Station, Manzgam.
