Srinagar, the 6th October, 2022.

SO-482.66 Whereas, on 17-04-2021, the Police Station, Magam received a docket to the effect that a reliable information was received about the presence of three persons identified as Adil Ahmad Dar S/o Bashir Ahmad Dar R/o Syed Mohallah, Narbal, Tahir Ahmad Bhat S/o Showket Ahmad Bhat R/o Narbal and Gh. Mohammad Gojri S/o Gh. Ahmad Gojri R/o Kawoosa, working as OGWs for the terrorists of LeT banned outfit, at Warihama, equipped with some illegal arms/

ammunition. Subsequently, a Joint Cordon and Search Operation was
launched and during the search the accused were arrested. During their
personal search, the Police recovered 15 AK-47 Rounds and 12 Posters
of LeT banned outfit from their possession respectively ; and

2. Whereas, based on the above, a Case FIR No. 51/2021 under
Section 7/25 Arms Act, 23 and 39 of ULA (P) Act, was registered in
the Police Station, Magam and the investigation of the case was set
into motion ; and

3. Whereas, during the investigation, the site plan of place of
occurrence and the seizure memos were prepared and the statements
of witnesses acquainted with the facts and circumstances of the case
were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, the accused viz. Adil Ahmad
Dar, Tahir Ahmad Bhat and Gh. Mohammad Gojri, were found in contact
with two terrorists of LeT banned outfit namely Mohd Yousuf Dar @
Kantroo S/o Ab. Gani Dar R/o Check Kawoosa and Abrar Nadeem Bhat
S/o Mohd Ramzan Bhat R/o Eidgah Mohalla, Narbal, who provided the
said ammunition and incriminatory material to the accused for promoting
the terrorist activities in the area ; and

5. Whereas, during the investigation, it was established that the
accused viz. Adil Ahmad Dar, Tahir Ahmad Bhat and Gh. Mohammad
Gojri, were working as Over Ground Workers (OGWs) for the terrorists
of LeT banned outfit particularly the terrorists namely, Mohd Yousuf
Dar @ Kantroo and Abrar Nadeem Bhat, and were providing logistic
support to them, besides, procured the ammunition/incriminatory material
from the terrorists for promoting the terrorist activities in the area ; and

6. Whereas, the accused terrorist namely, Mohd Yousuf Dar @
Kantroo and Abrar Nadeem Bhat, have been killed in an encounter with
the security forces and the proceedings under the law would abate against
them ; and

7. Whereas, on the basis of the investigation, the statement of
witnesses recorded and other evidence collected, the Investigating Officer,
has established *prima facie* involvement of the below mentioned accused
