Srinagar, the 7th October, 2022.

SO-486.66Whereas, on 13-08-2016, the Police Station, Pulwama received a docket to the effect that some miscreants from the adjacent villages headed by one Nazir Ahmad Dar S/o Mohammad Ramzan Dar R/o Bonigund, Kakapora, gathered in Village Marvel, Kakapora and raised anti-national slogans against the sovereignty and territorial integrity of the country; and

2. Whereas, based on the above, a Case FIR No. 339/2016 under Section 13 of ULA (P) Act, was registered in Police Station, Pulwama and the investigation of the case was set into motion; and

- 3. Whereas, during the course of investigation, the site plan of place of occurrence and seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, 12 other persons identified as Abdul Waheed Reshi S/o Ghulam Ahmad Reshi R/o Khadermoh, Bashir Ahmad Dar S/o Ab. Gaffar Dar, Ashiq Ahmad Reshi S/o Ghulam Ahmad Reshi, Mohammad Maqbool Dar S/o Ghulam Mohd Dar, Abdul Ahad Dar S/o Ghulam Ahmad Dar, Bashir Ahmad Pandith S/o Ghulam Nabi Pandith, Firdous Ahmad Dar S/o Abdul Gani Dar, Bashir Ahmad Dar S/o Mohd Ismail Dar, Mohd Younis Dar S/o Assadullah Dar, Lateef Ahmad Malik S/o Ghulam Mohd Malik, Sajad Ahmad Malik, Sameer Ahmad Malik S/o Ghulam Mohd Malik, Sajad Ahmad Malik S/o Amma Malik, Rs/o Marvel, Kakapora were found involved in the commission of offence. Subsequently, the accused along with the accused viz. Nazir Ahmad Dar, were arrested in the case: and
- 5. Whereas, during the investigation, it was established that on the date of occurrence the accused viz. Nazir Ahmad Dar, Abdul Waheed Reshi, Bashir Ahmad Dar, Ashiq Ahmad Reshi, Mohammad Maqhool Dar, Abdul Ahad Dar, Bashir Ahmad Pandith, Firdous Ahmad Dar, Bashir Ahmad Dar, Mohd Younis Dar, Lateef Ahmad Malik, Sameer Ahmad Malik and Sajad Ahmad Malik, gathered in the Village Marvel, Kakapora, and raised anti-national slogans against the sovereignty and territorial integrity of the Union of India; and

Whereas, on the basis of the investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has established *prima facie* involvement of the below mentioned accused for the commission of offences punishable under sections of the Unlawful Activities (Prevention) Act, 1967, as shown against their name :ô

- 7. Whereas, the Authority, appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the

Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for their prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Nazir Ahmad Dar, Abdul Waheed Reshi, Bashir Ahmad Dar, Ashiq Ahmad Reshi, Mohammad Maqbool Dar, Abdul Ahad Dar, Bashir Ahmad Pandith, Firdous Ahmad Dar, Bashir Ahmad Dar, Mohd Younis Dar, Lateef Ahmad Malik, Sameer Ahmad Malik and Sajad Ahmad Malik, for the commission of offence punishable under Section 13 of ULA (P) Act, arising out of FIR No. 339/2016 of Police Station, Pulwama.
