SO-488.66Whereas, on 23-04-2022, information was received by Police Station, Rajbagh to the effect that a person namely Mohd Ishfaq S/o Mohd Shafi R/o Malsoo, Doda, is associated with one terrorist namely Mohd Amin @ Khubib R/o Thatri, Doda A/P in Pakistan and the duo, in association of some other persons/inhabitants of Border villages of Tehsil Merheen and Hiranagar areas of District Kathua, are indulging in anti-national and terror activities aimed against the integrity and 2. Whereas, based on the above, case FIR No. 86/2022 under Sections 120-B, 121, 121-A, IPC and 13, 16, 18, 38 & 39 of ULA (P) Act, 1967 was registered in Police Station, Rajbagh and investigation was taken up. Subsequently, during the investigation Section 23 of ULA (P) Act was added, whileas Section 16 of ULA(P) Act was dropped from the case ; and

3. Whereas, during course of investigation, site plan of place of occurrence and seizure memos were prepared and statement of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigatton, it was established that the accused viz. Mohd Ishfaq, was arrested in the case and it was found that he was in contact with the terrorist viz. Mohd Amin @ Khubib, and presently based in PaK, through virtual mode ; and

5. Whereas, during further investigation, it was found that one more person namely Makhan Din @ Shah Hussain S/o Late Bika R/o Merheen, who was in constant touch with the accused viz. Mohd Ishfaq in furtherance of the criminal conspiracy for procurement of arms/ ammunition. The accused managed to procure some ammunition and other incriminate material. The accused viz. Makhan Din @ Shah Hussain, was already in custody in case FIR No. 08/2021 of Police Station, Rajbagh wherefrom, the custody of the accused has been changed to the instant case under the order of the Competent Court of Law ; and

6. Whereas, during the investigation, it was established that accused viz. Mohd Ishfaq and Makhan Din @ Shah Hussain, were working as OGWs for the terrorists of LeT banned outfit particularly Mohd Amin @ Khubib, and under a well knit conspiracy were providing logistic/ other support including transportation of arms/ammunition to facilitate and promote terrorist activities in the area and to wage war against the Government of India ; and

7. Whereas, the accused terrorists viz. Mohd Amin @ Khubib, is absconding and proceedings under Section 299 Cr. PC, are proposed to be initiated against him ; and

8. Whereas, on the basis of investigation, statement of witnesses recorded and other evidence collected, the Investigating Officer has established, *prima facie*, involvement of below mentioned accused for the commission of offence punishable under sections as shown against their name of the Unlawful Activities (Prevention) Act, 1967 and sections of the Indian Penal Code :ô

9. Whereas, the Government has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused under Sections 121 and 121-A Indian Penal Code ; and

10. Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967 has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above-accused ; and

11. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, and in pursuance of Section 196 of the Code of Criminal Procedure, 1973, the Government hereby accord sanction for launching prosecution against the accused viz. Mohd Ishfaq, Makhan Din @ Shah Hussain and Mohd Amin @ Khubib for the commission of offences punishable under relevant sections of the Unlawful Activities (Prevention) Act, 1967, indicated against each at para (9) above, arising out of FIR No. 86/2022 of Police Station, Rajbagh, Kathua.
