SO-493.66Whereas, on 01-03-2019, the Police Station, Manzgam received a reliable information to the effect that some members of Jamaate-Islami (JeI) a banned Association, are propagating the idology of the said association in the area and were organization meeting in order to provoke youth against the integrity and sovereignty of India, besides were providing assistance to the terrorist organizations ; and 2. Whereas, based on the above, a Case FIR No. 04/2019 under Sections 10, 13 of ULA (P) Act, was registered in Police Station, Manzgam and the investigation of the case was set into motion ; and

3. Whereas, during the course of investigation, the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, three persons identified as Zeenat-ul-Islam S/o Ab. Waheed Magray R/o Watoo, Imtiyaz Ahmad Parray S/o Gh. Mohi-ud-Din Parray R/o KB Pora and Mohammad Sikander Lone S/o Ab. Gani Lone R/o Mirwani, were found involved in the case. Subsequently, the accused were arrested in the case ; and

5. Whereas, during the investigation, it was established that the accused viz. Zeenat-ul-Islam Magray, Imtiyaz Ahmad Parray and Mohd Sikander Lone, were members of Unlawful Association Jamaat-e-Islami, (JeI) Jammu and Kashmir and were carrying out the unlawful activities in the area, besides, were provoking the youth against the integrity, sovereignty and security of the Union of India ; and

6. Whereas, on the basis of the investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has established *prima facie* involvement of the below mentioned accused for the commission of offences punishable under sections of the Unlawful Activities (Prevention) Act, 1967, as shown against their name :ô

- 1. Zeenat-ul-Islam Magray S/o10, 13 of ULA (P)Ab. Waheed Magray R/o Watoo.Act.
- 2. Imtiyaz Ahmad Parray S/o Gh. Mohi-ud-Din Parray R/o KB Pora.
- 3. Mohd Sikander Lone S/o Ab. Gani Lone R/o Mirwani.

7. Whereas, the Authority, appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the 8. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for their prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Zeenat-ul-Islam, Imtiyaz Ahmad Parray and Mohammad Sikander Lone, for the commission of offence punishable under Sections 10 and 13 of ULA (P) Act, arising out of FIR No. 04/2019 of Police Station, Manzgam.
