Srinagar, the 29th October, 2022.

SO-553.66Whereas, on 25-10-2019, the Police Station, Manzgam received a docket to the effect that some unknown miscreants pasted the posters of terrorist organization Afgan Taliban, on the electric polls in Manzgam Market, in order to spread terrorist among the general public and Govt. employees, have been threatened to remain at their homes, besides, provoked the masses to raise slogans after friday prayers ; and

2. Whereas, based on the above, a Case FIR No. 58/2019 under Section 13 of ULA (P) Act and 506 RPC, was registered in Police Station, Manzgam and investigation of the case was set into motion ; and

3. Whereas, during the course of investigation, the site plan of the place of occurrence and seizure memos were prepared and the statement of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law ; and

4. Whereas, during the investigation, one Aamir Rasheed Sheikh S/o Abdul Rasheed Sheikh R/o Khud Hajipora, Manzgam, was found involved in the commission of crime. Subsequently, the accused was arrested in the case ; and

5. Whereas, during the investigation, it was found that on the date of occurrence the accused viz. Aamir Rasheed Sheikh, pasted the posters of Afgan Taliban, a terrorist organization, in the Manzgam area, thereby threatened the sovereignty and territorial integrity of the Union of India ; and

6. Whereas, on the basis of investigation, and other evidence collected, the Investigating Officer has established, *prima facie*, involvement of below mentioned accused in the commission of the offences punishable under section of the Unlawful Activities (Prevention) Act, 1967, as shown against his name :ô

Rasheed Sheikh R/o Khud, Hanjipora, Manzgam.

7. Whereas, the Authority, appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused ; and

8. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Aamir Rasheed Sheikh, for the commission of offences punishable under Section 13 of ULA (P) Act, arising out of FIR No. 58/2019 of Police Station, Manzgam.
