Srinagar, the 29th October, 2022.

SO-557.ôôWhereas, on 10-05-2022, the Police Station, Dooru received a docket to the effect that an information was received about the hiding of some unknown terrorists in the residential house of one Mohd Shafi Padder S/o Ghulam Hassan Padder R/o Kreeri, Dooru. Subsequently, a Joint Cordon and Search Operation was launched by the Police/Security Forces. During the search, the hiding terrorists fired

indiscriminately upon the search party with their illegal arms/ammunition,
with the intention to kill them, resulting in the injures to four Army
personnel. The fire was retaliated which triggering an encounter ; and

2. Whereas, based on the above, a Case FIR No. 38/2022 under
Section 307 IPC 7/27 Arms Act, 16, 18, 19, 20 and 39 of ULA (P)
Act, was registered in Police Station, Dooru and the investigation of
the case was set into motion. Subsequently, during the investigation, the
Section 324 IPC was added in the case ; and

3. Whereas, during the investigation, two dead bodies were
recovered from the encounter site who were later on identified as the
terrorists of HM/LeT banned outfit identified as Aarif Hussain Bhat
S/o Ab. Ganie Bhat R/o Heeward, Kapran and Suhail Ahmad Lone
S/o Fayaz Ahmad Lone R/o Owgam, Kulgam. During search, arms/
ammunition viz. 01 AK-56 Rifle, 02 AK Magazines, 100 AK Rounds,
01 Pistol, 02 Pistol Magazines and 11 Pistol Rounds, were also recovered
from the encounter site ; and

4. Whereas, during the course of investigation, the site plan of the
place of occurrence and seizure memos were prepared and the statement
of witnesses acquainted with the facts and circumstances of the case
were recorded under the relevant provisions of law ; and

5. Whereas, during the investigation, the accused house owner viz.
Mohd Shafi Padder, was arrested in the case and it was established
that the accused was working as Over Ground Worker (OGW) for the
terrorists of HM/LeT banned outfit particularly the killed terrorists viz.
Aarif Hussain Bhat and Suahil Ahmad Lone, and was providing logistic
support to them, besides, on the date of occurrence voluntarily harboured
the terrorists in his residential house for carrying out the terrorist activities
in the area ; and

6. Whereas, the accused terrorist viz. Aarif Hussain Bhat and Suhail
Ahmad Lone, have been killed in the said encounter and the proceedings
under the law would abate against them ; and

7. Whereas, on the basis of investigation, and other evidence
collected, the Investigating Officer has established, *prima facie*, involvement
of below mentioned accused in the commission of the offences punishable
