SO-650. Whereas, on 29-06-2022, the Police Station, Bandipora, received a docket to the effect that a joint Naka was established by the Police/Security Forces at Papchan, Bandipora and during the checking, a suspect boarding on the Scooty tried to escape but was chased down on the spot and identified as Mehboob-ul-Inam Shah @ Farhan S/o Inamul Haq Shah R/o Nadihal, Bandipora. During checking a hand grenade was recovered from the dicky of his Scooty ; and

2. Whereas, based on the above, a Case FIR No. 112/2022 under section 4(b) ESA and 23 of ULA(P) Act, was registered in Police Station, Bandipora and the investigation of the case was set into motion.

8. Whereas, on the basis of investigation, and other evidence collected, the Investigating Officer has established prima facie, involvement of below mentioned accused in the commission of the offences punishable under Section of the Unlawful Activities (Prevention) Act, 1967, as shown against their name :ô

9. Whereas, the accused terrorist namely, Hashier Rafiq Parray @ Hamza Bhai, is absconding and the proceedings under section 299 Cr. PC have been proposed to be initiated against him ; and

10. Whereas, the Authority, appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to be conclusion that a prima facie case is made out against the above accused ; and

11. Whereas, after perusing the Case Diary File the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities

sufficient material and evidence available against the above mentioned
accused for their prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-
Section (2) of Section 45 of the Unlawful Activities (Prevention) Act,
1967, the Government hereby accord sanction for launching prosecution
against the accused viz. Mehboob-ul-Inam Shah @ Farhan, Shariq
Ahmad Lone @ Momin and Hashier Rafiq Parray @ Hamza Bhai, for
the commission of offences punishable under the relevant Sections of
ULA(P) Act, as indicated against each accused at Para (8) above,
arising out of FIR No. 112/2022 of Police Station, Bandipora.
