### Notification

Jammu, the 13th December, 2022.

SO-682.66Whereas, on 08-09-2021, the Police Station, Bandipora, received a docket to the effect that a Naka was established by the Police at Kema crossing and during the checking a lady while seeing the Naka party tired to escape but was chased down on the spot and identified as Mst. Haseena Begum W/o Mohammad Yousuf Bhat R/o Sheeri, Baramulla. During her personal search, the Police recovered 01 Hand Grenade and 24 Posters of TuM/HM and LeT banned outfits respectively; and

2. Whereas, a case FIR No. 151/2021 under Sections 7/25 Arms Act, 124-A, 505(b), 506 IPC 3/4 ESA and Section 13 of ULA (P) Act

- 3. Whereas, during the investigation, the site plan of place of occurrence and the seizure memos were prepared and the statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during the investigation, the accused lady namely Mst. Haseena Begum, was found in contact with the terrorists of TuM/HM and LeT banned outfits who provided the hand grenade and incriminatory material to the accused lady in order to promote terrorist activities in the area; and
- 5. Whereas, during the investigation, it was established that the accused lady viz. Mst. Haseena Begum, was working as Over Ground Worker (OGW) for the terrorists of TuM/HM and LeT banned outfits and was providing logistic support to them, besides, procured hand grenade and incriminatory material from the terrorists of the outfit for carrying out the terrorist activities in the area; and

Whereas, on the basis of the investigation, the statement of witnesses recorded and other evidence collected, the Investigating Officer, has established *prima facie* involvement of the below mentioned accused for the commission of offences punishable under sections of the Unlawful Activities (Prevention) Act, 1967, as shown against her name :ô

- 7. Whereas, the Authority, appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, has independently examined the Case Diary File and all the

Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the above-mentioned accused for her prosecution under the provisions of law.

Now, therefore, in exercise of the powers conferred by Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government hereby accord sanction for launching prosecution against the accused viz. Mst. Haseena Begum, for the commission of offences punishable under Sections 13, 23 and 39 of ULA (P) Act, arising out of FIR No. 151/2021 of Police Station, Bandipora.
