Notification

Jammu, the 24th February, 2022.

S.O.-79.ô Whereas, on 22-08-2021, Baramulla Police received reliable information that one active terrorist of LeT banned outfit Hilal Ahmad Sheikh S/o Ab. Hameed Sheikh R/o Shirakwara lobbed a hand grenade upon the house of Sarpanch Narinder Kour W/o Daljeet Singh R/o Shirakwara, causing damage to the house and vehicle of the Sarpanch; and

- 2. Whereas, a Case FIR No. 90/2021 under Sections 307, 427 IPC, 3-4 Explosive Substances Act, came to be registered in Police Station Kreeri and investigation, of the case was taken up. Subsequently, during investigation, sections 16, 18, 20, 23 ULA (P) Act were added in the case; and
- 3. Whereas, during the course of investigation, site plan of place of occurance and seizure memos were prepared and statements of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during investigation, one suspect Mohammad Saleem Khan S/o Gh. Hassan R/o New Colony, Shirakwara was arrested in connection with the case who durings questioning disclosed that he procurred 03 hand grenades from Srinagar on the directions of active terrorist Hilal Ahmad Sheikh S/o Ab. Hameed R/o Shirakwara and handed over to his associates Sajad Ahmad Mir S/o Ali Mohammad R/o Saloosa and Nasir Ahmad Dar S/o Ab. Majeed R/o Najibhat for carrying out the terrorists activities in the area; and
- 5. Whereas, accused Mohammad Saleem Khan further disclosed that he alongwith above two accused persons and one more associate namly Bilal Ahmad Sheikh S/o Mohammad Maqbool R/o Vizeer Wagoora conspired to attack upon the Police, Secuirty forces and Political leaders in the area and on 22-8-2021 hurled one hand grenade upon the residence of Sarpanch Narinder Kour. Subsequently, all the accused persons were arrested in the case and two hand grenades were recovered on the disclosure of accused Mohammad Saleem Khan and Sajad Ahmad Mir. The investigation in respect of accused terrorist Hilal Ahmad Seikh is going on; and
- 6. Whereas, during investigation, it was established that the accused persons Mohammad Saleem Khan, Sajad Ahmad Mir, Nasir Ahmad Dar and Bilal Ahmad Sheikh were members of terrorist gang/organization and under well knit criminal conspiracy hurled hand grenade upon the residence of Sarpanch Narinder Kour in order to kill her which resulted damage to the house and vehicle of the said Sarpanch; and
- 7. Whereas, on the basic of Investigation, statement of witnesses recorded and other evidence collected, the Investigating Officer has

- 4. Bilal Ahmad Sheikh S/o Mohammad Maqbool R/o Vizer Wagoora
- 8. Whereas, accused namely Mohammad Saleem Khan has been found juvenile during the investigation and in view of Section 1(4) of the Juvenile Justice (Care and Protection of Children) Act, 2015, the apprehension, detention, prosecution, penalty or imprisonment shall be governed by the said Act; and
- 9. Whereas,the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967 has independently examined the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that a *prima facie* case is made out against the above accused persons; and
- 10. Whereas, after perusing the Case Diary File, the relevant documents and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the accused persons for their prosecution under the provisions of law.

Now therefore, in exercise of powers conferred by Sub-Section (02) of Section 45 ULA (P) Act 1967, the Government hereby accord sanction for launching prosecution against the accused persons namely
