## Notification

Jammu, the 4th March, 2022.

SO685.ô Whereas, on 11-02-2021, Police Station, Doda received reliable information that some unknown persons lobbed grenade upon the house of one Satish Kumar S/o Bhagat Ram Gaddi R/o Brown Gadyari with intention to kill his family members. The grenade exploded causing damage to the house hold items; and

- 2. Whereas, in this connection, case FIR No. 26/2021 under sections 307, 427 IPC, 7/27 Arms Act came to be registered in Police Station, Doda and investigation of the case was taken up. Subsequently, during investigation section 7/27 Arms Act was dropped and Section 3/5 Explosive Substances Act, 201 IPC and Sections 13, 16, 18, 21, 23, 39 ULA (P) Act, 1967 were added in the case; and
- 3. Whereas, during course of investigation, site plan of place of occurence and seizure memos were prepared and statement of witnesses acquainted with the facts and circumstances of the case were recorded under the relevant provisions of law; and
- 4. Whereas, during investigation, a person namely Shahbaz Ahmad S/o Gh. Nabi Aetoo R/o Dalyoung, Udhyanpur was found involved in commission of offence. Subsequently, the accused was arrested in connection with the case and was found in constant touch with an active terrorist namely Nazir Ahmad Gujjar @ Abu Manazir presently in Pak and on his directions lobbed grenade upon the house of Satish Kumar; and
- 5. Whereas, during investigation, the accused disclosed that PoK handler Nazir Ahmad Gujjar @ Abu Manazir directed him to throw another grenade on any Army/Police establishment and the said grenade was recovered in a culvert near Udhyanpur, District Doda; and
- 6. Whereas, during investigation, it was established that accused Shahbaz Ahmad was working as Over Ground Worker (OGW) for the PAK based terrorist of banned LeT outfit Nazir Ahmad Gujjar @ Abu Manzair and under well knit conspiracy hurled hand greande upon the house of Satish Kumar in order to kill him and his family members. The investigation of respect of PAK based terrorist is going on to bring out his role in the commission of offence; and
- 7. Whereas, on the basis of investigation, statement of witnesses recorded and other evidence collected, the investigating Officer has established *prima facie* involvement of below mentioned accused for the commission of offences punishable under section as shown against his name of the Unlawful Activities (Prevention) Act, 1967 :ô

ULA (P) Act.

- 8. Whereas, the Authority appointed by the Government under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevntion) Act, 1967, has independently Serutinized the Case Diary File and all the other relevant documents relating to the case and has come to the conclusion that *prima facie* case is made out against the accused; and
- 9. Whereas, after perusing the Case Diary File, the relevant documants and also taking into consideration the views of the Authority appointed under Sub-Section (2) of Section 45 of the Unlawful Activities (Prevention) Act, 1967, the Government is of the view that there is sufficient material and evidence available against the accused for his prosecution under the provisions of law.

Now, therefore, in exercise of powers conferred by Sub-Section (2) of Section 45 of Unlawful Activities (Prevention) Act 1967, the Government hereby accords sanction for launching prosecution against the accused viz. Shahbaz Ahmad for the commission of offences punishable under Sections 13, 16, 18, 21, 23, 39 of Unlawful Activities (Prevention) Act, 1967, arising out of FIR No. 26/2021 of Police Station, Doda.
