Subject: India Disaster Resource Network (IDRN) portal and updation thereof.

Circular No: 03-JK (DMRRR) of 2021 Dated: 02-12-2021

The UT of Jammu & Kashmir is exposed to natural hazards like floods, droughts, gale winds and earthquakes which are not rare or unusual phenomenon in the UT. The vulnerability varies from region to region, which often turn into disasters causing significant disruption of socio-economic life of communities leading to loss of life and property.

The **India Disaster Resource Network (IDRN)** is a web-based platform for managing the following:

- a) Inventory of equipment;
- b) Skilled human resources; and
- c) Critical supplies for emergency response.

It was initiated by Ministry of Home Affairs (MHA) under the GoI – UNDP Disaster Risk Management (DRM) programme with the aim to build up a systematic inventory of equipment and skilled human resources, so that disaster managers can find the location and details of the resources for immediate response.

National Institute of Disaster Management (NIDM), Ministry of Home Affairs, Government of India, is managing the IDRN portal since June 2008. The online inventory of resources i.e., IDRN, is hosted in the National Informatics Centre (NIC), New Delhi. NIDM is responsible for maintaining and monitoring the data and the portal. Authorized government officers have access to the portal and the District Authorities are authorized for uploading and updating the data time to time after

collecting it from various line departments of their respective districts. The updation of the information on IDRN portal is the responsibility of the District Authorities.

As such through the medium of this circular, it is enjoined upon all the Deputy Commissioners of the UT of J&K (Chairman DDMA), to ensure uploading and up-date of the data on India Disaster Resource Network (IDRN) portal so that such pro-active mechanism may help in containing the effects of any future disaster.

Note:- Each Chairman of DDMA shall designated an officer in their respective Districts by entrusting responsibility to him/her to regularly upload data on IRDN under intimation to DoDMRRR.
